1.5 Section 1. Minnesota Statutes 2019 Supplement, section 124D.68, subdivision 2, is  
1.6 amended to read:

1.7 Subd. 2. **Eligible pupils.** (a) A pupil under the age of 21 or who meets the requirements  
1.8 of section 120A.20, subdivision 1, paragraph (c), is eligible to participate in the graduation  
1.9 incentives program, if the pupil:

1.10 (1) performs substantially below the performance level for pupils of the same age in a  
1.11 locally determined achievement test;

1.12 (2) is behind in satisfactorily completing coursework or obtaining credits for graduation;

1.13 (3) is pregnant or is a parent;

1.14 (4) has been assessed as chemically dependent;

1.15 (5) has been excluded or expelled according to sections 121A.40 to 121A.56;

1.16 (6) has been referred by a school district for enrollment in an eligible program or a  
1.17 program pursuant to section 124D.69;

1.18 (7) is a victim of physical or sexual abuse;

1.19 (8) has experienced mental health problems;

1.20 (9) has experienced homelessness sometime within six months before requesting a  
1.21 transfer to an eligible program;

1.22 (10) speaks English as a second language or is an English learner;

1.23 (11) has withdrawn from school or has been chronically truant; or

1.24 (12) is being treated in a hospital in the seven-county metropolitan area for cancer or  
1.25 other life threatening illness or is the sibling of an eligible pupil who is being currently

 2.9 A district's compensatory revenue equals the sum of its compensatory revenue for each  
 2.10 building in the district and the amounts designated under Laws 2015, First Special Session  
 2.11 chapter 3, article 2, section 70, subdivision 8, for fiscal year 2017. Revenue shall be paid

### 2.27 SCHOOL CLOSURES DUE TO COVID-19

2.28 Section 1. **TRUANCY.**

2.29 Notwithstanding Minnesota Statutes, section 260A.02, subdivision 3, a student's absence,  
 2.30 without valid excuse, beginning March 1, 2020, and through the end of the distance learning  
 2.31 period or June 30, 2020, for school districts and charter schools that operate on an approved

3.1 flexible learning year calendar, does not bring the student within the definition of a continuing  
3.2 truant.

3.3 **EFFECTIVE DATE.** This section is effective the day following final enactment and  
3.4 expires June 30, 2020.

3.5 **Sec. 2. PROBATIONARY TEACHERS.**

3.6 For the 2019-2020 school year only, for purposes of Minnesota Statutes, sections  
3.7 122A.40, subdivision 5, paragraph (e), and 122A.41, subdivision 2, paragraph (d), the  
3.8 minimum number of days of teacher service that a probationary teacher must complete  
3.9 equals the difference between 120 days and the number of scheduled instructional days that  
3.10 were canceled for COVID-19-related reasons.

3.11 **EFFECTIVE DATE.** This section is effective the day following final enactment and  
3.12 expires June 30, 2020.

3.13 **Sec. 3. INSTRUCTION TO COMMISSIONER; FEDERAL EDUCATION**  
3.14 **STABILIZATION FUND APPLICATION.**

3.15 In applying for education stabilization fund grants authorized under the federal  
3.16 Coronavirus Aid, Relief, and Economic Security Act, the Department of Education must  
3.17 prioritize distribution and expenditure of funds that enables a school to comply with the  
3.18 governor's Executive Order 20-19 and any future executive order on kindergarten through  
3.19 grade 12 education that relates to the infectious disease known as COVID-19, as well as  
3.20 the corresponding Department of Education guidance related to the COVID-19 pandemic,  
3.21 including employee compensation.

3.22 **EFFECTIVE DATE.** This section is effective the day following final enactment and  
3.23 expires June 30, 2020.

3.25 **FORMULA ADJUSTMENTS**

3.26 Section 1. Minnesota Statutes 2018, section 134.355, subdivision 8, is amended to read:

3.27 Subd. 8. **Eligibility.** (a) A regional public library system may apply for regional library  
3.28 telecommunications aid on behalf of itself and member public libraries.

3.29 (b) The aid must be used for connections and other eligible non-voice-related e-rate  
3.30 program category one services. Aid may be used for e-rate program category two services  
3.31 as identified in the Federal Communication Commission's eligible services list for the current

6.7 Subdivision 1. **Special education.** Notwithstanding any law to the contrary, fiscal year  
6.8 2020 expenditures for employees and contracted services that would have been eligible for  
6.9 state special education aid under Minnesota Statutes, section 125A.76, and for special  
6.10 education tuition billing under Minnesota Statutes, sections 125A.11 and 127A.47, in the  
6.11 absence of school closures or learning plan modifications due to COVID-19 must be included  
6.12 as eligible expenditures for the calculation of state special education aid and special education  
6.13 tuition billing.

6.14 Subd. 2. **School meals.** (a) Notwithstanding any law to the contrary, for school meals  
6.15 served beginning on or after March 16, 2020, the commissioner of education may adjust  
6.16 the appropriations remaining under Laws 2019, First Special Session chapter 11, article 7,  
6.17 section 1, subdivisions 2, 3, and 4, as specified in paragraph (b).

6.18 (b) On June 30, 2020, the commissioner must subtract the amount actually paid to  
6.19 participants for the 2019-2020 school year under Laws 2019, First Special Session chapter  
6.20 11, article 7, section 1, subdivisions 2, 3, and 4, through March 15, 2020, from the total  
6.21 appropriations for each program. The commissioner must then allocate the remaining funds  
6.22 under each appropriation to participants in the summer food service program on a per meal  
6.23 basis for meals served on or after March 16, 2020, and before July 1, 2020.

6.24 Subd. 3. **Career and technical aid.** Notwithstanding any law to the contrary, for fiscal  
6.25 years 2020 and 2021, the commissioner of education may recalculate career and technical  
6.26 revenue for school districts, cooperatives, and charter schools to ensure that the total statewide  
6.27 career and technical revenue does not fall below the amount estimated for fiscal years 2020  
6.28 and 2021 based on the February 2020 forecast. For expenses incurred on or after March 18,  
6.29 2020, the commissioner may recalculate school district, cooperatives, and charter school  
6.30 amounts based on any other mechanism that allows for the full amount of this appropriation  
6.31 to be equitably paid to school districts, cooperatives, and charter schools. These amounts  
6.32 must be prorated at the end of each year if career and technical revenue were to exceed the  
6.33 February 2020 forecast estimate of this revenue for these fiscal years.

7.1 Subd. 4. **Nonpublic pupil transportation aid.** Notwithstanding any law to the contrary,  
7.2 the commissioner of education may adjust the fiscal year 2020 pupil transportation  
7.3 expenditures used to determine nonpublic pupil transportation aid for fiscal year 2022 based  
7.4 on any mechanism that allows for the full amount of the state total fiscal year 2020  
7.5 expenditure estimated in the February 2020 forecast to be equitably allocated among school  
7.6 districts.

7.7 Subd. 5. **Interdistrict desegregation or integration transportation**  
7.8 grants. Notwithstanding any law to the contrary, the commissioner of education may adjust  
7.9 the fiscal year 2020 pupil transportation expenditures used to determine interdistrict  
7.10 desegregation and integration aid for fiscal year 2021 based on any mechanism that allows  
7.11 for the full amount of the state total fiscal year 2020 expenditure estimated in the February  
7.12 2020 forecast to be equitably allocated among school districts.

7.13 Subd. 6. **Adult basic education aid.** Notwithstanding any law to the contrary, for the  
7.14 2020-2021 school year only, the commissioner of education may recalculate adult basic  
7.15 education aid to ensure that the total aid does not fall below the amount estimated for the  
7.16 2020-2021 school year based on the February 2020 forecast. The commissioner may  
7.17 recalculate contact hour rate or otherwise adjust the formula so that the full amount of this  
7.18 appropriation to be equitably paid to aid recipients. These amounts must be prorated at the  
7.19 end of the year if adult basic education aid were to exceed the February 2020 forecast  
7.20 estimate of this aid.

7.21 Subd. 7. **School employees; ensuring state revenue.** Notwithstanding any law to the  
7.22 contrary, for purposes of state aid formulas under subdivisions 1 and 3, the commissioner  
7.23 of education may include in any counts and costs of essential personnel the services provided  
7.24 by individuals who were essential personnel prior to March 13, 2020, for the purpose of  
7.25 ensuring state aid payments to school districts, cooperative units, and charter schools are  
7.26 consistent with the February 2020 forecast.

7.27 Subd. 8. **Literacy incentive aid.** Notwithstanding Minnesota Statutes, section 124D.98,  
7.28 for purposes of calculating proficiency aid and growth aid for fiscal years 2021, 2022, and  
7.29 2023 only, tests administered during the 2019-2020 school year must be excluded from the  
7.30 three year average proficiency percentage and from the three year average growth percentage.  
7.31 The commissioner may adjust the dollar amounts for proficiency aid and growth aid for  
7.32 fiscal years 2021, 2022, and 2023 only, to ensure that the total statewide literacy incentive  
7.33 aid amount does not fall below the amount estimated for these fiscal years based on the  
7.34 February 2020 forecast.

8.1 Subd. 9. **School-age care revenue.** Notwithstanding Minnesota Statutes, section 124D.22,  
8.2 for fiscal year 2020 and 2021 only, for spending on or after March 18, 2020, each district's  
8.3 school-age care revenue continues at its approved amounts and program funds may be spent  
8.4 consistent with the process and limitations of section 8 of this article.

8.5 Subd. 10. **Early childhood screening revenue.** Notwithstanding any law to the contrary,  
8.6 for fiscal years 2020 and 2021 only, the commissioner of education must calculate each  
8.7 school district's early childhood screening revenue under Minnesota Statutes, section  
8.8 121A.19, using the formula amounts set in statute for each age group and the 2018-2019  
8.9 school year counts of children screened for each age group.

8.10 Subd. 11. **Achievement and integration revenue.** Notwithstanding Minnesota Statutes,  
8.11 section 124D.861 or 124D.862, or any other law to the contrary, for fiscal year 2020 only,  
8.12 a school district that has not spent the full approved amount of its achievement and integration  
8.13 revenue may carry the unspent portion of that revenue forward into fiscal year 2021.

8.14 Subd. 12. **Report.** The commissioner of education must notify school districts and charter  
8.15 schools of these formula changes as soon as practicable. The commissioner must issue a  
8.16 report by January 15, 2021, to the chairs and the ranking minority members of the legislative  
8.17 committees having jurisdiction over kindergarten through grade 12 education matters  
8.18 describing the formula changes and the distributional impact on school districts and charter  
8.19 schools.

8.20 **EFFECTIVE DATE.** This section is effective the day following final enactment.

8.21 Sec. 7. **ACCOUNTING.**

8.22 Notwithstanding any law to the contrary, services paid under section 6, including expenses  
8.23 recorded in the food service fund, may be charged to the same Uniform Financial Accounting  
8.24 and Reporting Standards codes to which the service is otherwise charged for an instructional  
8.25 day.

8.26 **EFFECTIVE DATE.** This section is effective the day following final enactment and  
8.27 is retroactive from the beginning of the 2019-2020 school year. This section expires June  
8.28 30, 2020.

8.29 Sec. 8. **FUND TRANSFERS; FISCAL YEARS 2020 AND 2021 ONLY.**

8.30 Subdivision 1. **Fund and account transfers allowed.** Notwithstanding Minnesota  
8.31 Statutes, section 123B.80, subdivision 3, for fiscal years 2020 and 2021 only, a school  
8.32 district, charter school, or cooperative unit may transfer any funds not already assigned to



9.1 or encumbered by staff salary and benefits, or otherwise encumbered by federal law, from  
9.2 any accounts or operating fund to the undesignated balance in any other operating fund.

9.3 Subd. 2. **No aid or levy effect.** A fund or account transfer is allowed under this section  
9.4 if the transfer does not increase state aid obligations to the district or school, or result in  
9.5 additional property tax authority for the district. A fund or account transfer is limited to the  
9.6 operating funds and accounts of a school district, charter school, or cooperative unit.

9.7 Subd. 3. **Board approval required; reporting; audit trail.** A fund or account transfer  
9.8 under this section for fiscal year 2020 is effective June 30, 2020, and a fund or account  
9.9 transfer under this section for fiscal year 2021 is effective June 30, 2021. The school board  
9.10 must approve any fund or account transfer before the reporting deadline for the respective  
9.11 fiscal year. A school district, charter school, or cooperative unit must maintain accounting  
9.12 records for the purposes of this section that are sufficient to document both the specific  
9.13 funds transferred and use of those funds. The accounting records are subject to auditor  
9.14 review. Any execution of flexibility must not interfere with or jeopardize funding per federal  
9.15 requirements. Any transfer must not interfere with the equitable delivery of distance learning  
9.16 or social distancing models.

9.17 Subd. 4. **Commissioner's guidance.** The commissioner must prepare and post to the  
9.18 department's website a document providing guidance on the process for approval of fund  
9.19 and account balance transfers authorized under this section.

9.20 **EFFECTIVE DATE.** This section is effective the day following final enactment and  
9.21 applies retroactively from March 18, 2020.

9.22 Sec. 9. **REVENUE RESTRICTIONS; FISCAL YEAR 2020 AND 2021 ONLY.**

9.23 Notwithstanding Minnesota Statutes, section 124D.19, subdivision 12, for fiscal year  
9.24 2020 and 2021 only, for spending occurring on or after March 18, 2020, after-school  
9.25 enrichment revenue under Minnesota Statutes, section 124D.20, subdivision 4a, may be  
9.26 spent consistent with the process and limitations of section 8 of this article.

9.27 **EFFECTIVE DATE.** This section is effective the day following final enactment.

9.28 Sec. 10. **CASH FLOW ADJUSTMENT; FISCAL YEAR 2021 ONLY.**

9.29 Notwithstanding any law to the contrary, for fiscal year 2021 only, a school district  
9.30 unable to make a required payment from its debt service fund because of a delay in receipt  
9.31 of its anticipated property tax proceeds may apply for modified cash flow payments under  
9.32 Minnesota Statutes, section 127A.45. The school district must apply in the form and manner

10.1 specified by the commissioner and the commissioner must adjust the state aid cash flow  
10.2 payments accordingly.

10.3 **EFFECTIVE DATE.** This section is effective the day following final enactment.

10.4 **ARTICLE 4**

10.5 **STATE AGENCY COVID-19 EMERGENCY POWERS**

10.6 Section 1. **COMMISSIONER OF EDUCATION AND PROFESSIONAL EDUCATOR**  
10.7 **LICENSING AND STANDARDS BOARD COVID-19 EMERGENCY POWERS.**

10.8 (a) Notwithstanding Minnesota Statutes, section 120B.30, for the 2019-2020 school year  
10.9 only, the commissioner of education is granted authority and must waive the state  
10.10 requirements on statewide assessments, including requirements allowing students to take a  
10.11 college entrance exam in school on a regular school day. The commissioner must waive  
10.12 any state accountability and reporting requirements linked to the statewide assessments.

10.13 (b) Notwithstanding Minnesota Statutes, section 122A.183, Minnesota Rules, part  
10.14 8710.0313, or any other law to the contrary, the Professional Educator Licensing and  
10.15 Standards Board must issue a one-year conditional Tier 3 license to an applicant that is  
10.16 otherwise qualified under Minnesota Statutes, section 122A.183, but was unable to complete  
10.17 the required licensure exams under Minnesota Statutes, section 122A.185, because of a  
10.18 COVID-19-related disruption. As a condition of renewing the Tier 3 license, the applicant  
10.19 must pass the required licensure exams under Minnesota Statutes, section 122A.185. The  
10.20 term of the renewed Tier 3 license under this section must be two years. The board must  
10.21 waive the licensure renewal fee.

10.22 (c) Notwithstanding any law to the contrary, the Professional Educator Licensing and  
10.23 Standards Board must extend by six months any calendar year 2020 deadline for completion  
10.24 of license renewal requirements for licenses under their jurisdiction.

10.25 **EFFECTIVE DATE.** Paragraph (a) of this section expires June 30, 2020. Paragraph  
10.26 (b) of this section expires October 31, 2020.

10.27 Sec. 2. **REPORTING; RIGHT OF ACTION.**

10.28 (a) A court must not construe anything in this article as creating a right of action for a  
10.29 student, parent, teacher license applicant, or any other individual or entity to enforce any  
10.30 provisions of this article.

10.31 (b) By December 15, 2020, the Professional Educator Licensing and Standards Board  
10.32 must report on all conditional licenses issued under section 1, paragraph (b), to the chairs

11.1 and the ranking minority members of the committees in the house of representatives and  
 11.2 the senate with jurisdiction over kindergarten through grade 12 education policy and finance.

11.3 **ARTICLE 5**

11.4 **MISCELLANEOUS CORRECTIONS**

11.5 Section 1. **[120B.126] CONSTRUCTION AND SKILLED TRADES COUNSELING.**

11.6 The commissioner of education must collaborate with the commissioner of labor and  
 11.7 industry to incorporate construction and skilled trades into career counseling services for  
 11.8 middle and high school aged students. Career advisement should identify high-growth,  
 11.9 in-demand skilled trades and include information on various career paths and associated  
 11.10 jobs, the salary profiles of those jobs, and the credentials and other training desired by  
 11.11 employers for those jobs.

11.12 Sec. 2. Minnesota Statutes 2019 Supplement, section 126C.17, subdivision 2, is amended  
 11.13 to read:

11.14 Subd. 2. **Referendum allowance limit.** (a) Notwithstanding subdivision 1, for fiscal  
 11.15 year 2021 and later, a district's referendum allowance must not exceed the greater of:

11.16 (1) the product of the annual inflationary increase as calculated under paragraph (b),  
 11.17 and \$2,079.50, minus \$300;
