12.15 with paid internships within STEM disciplines

13.9 overcoming barriers that prevent fathers from  
13.10 supporting their children economically and

- 13.19 (n) \$750,000 each year is from the workforce

13.21 Alliance of Boys and Girls Clubs to administer  
13.22 a statewide project of youth job skills and  
13.23 career development. This project, which may  
13.24 have career guidance components including  
13.25 health and life skills, must be designed to  
13.26 encourage, train, and assist youth in: early  
13.27 access to education and job-seeking skills;  
13.28 work-based learning experience including  
13.29 career pathways in STEM learning, career  
13.30 exploration, and matching; and first job  
13.31 placement through local community  
13.32 partnerships and on-site job opportunities. This  
13.33 grant requires a 25 percent match from  
13.34 nonstate sources. This is a onetime  
13.35 appropriation.

14.1 (o) \$250,000 each year is from the workforce  
14.2 development fund for grants to the Minnesota  
14.3 Grocers Association Foundation for Carts to  
14.4 Careers, a statewide initiative to promote  
14.5 careers, conduct outreach, provide job skills  
14.6 training, and grant scholarships for careers in  
14.7 the retail food industry. This is a onetime  
14.8 appropriation.

14.9 (p) \$250,000 the first year is from the  
14.10 workforce development fund for a grant to the  
14.11 ProStart and Hospitality Tourism Management  
14.12 Program for a well-established, proven, and  
14.13 successful education program that helps young  
14.14 people advance careers in the hospitality  
14.15 industry and addresses critical long-term  
14.16 workforce shortages in that industry.

14.17 (q) \$375,000 each year is from the workforce  
14.18 development fund for a grant to the  
14.19 Construction Careers Foundation for the  
14.20 construction career pathway initiative to  
14.21 provide year-round educational and  
14.22 experiential learning opportunities for teens  
14.23 and young adults under the age of 21 that lead  
14.24 to careers in the construction industry. This is  
14.25 a onetime appropriation. Grant funds must be  
14.26 used to:

14.27 (1) increase construction industry exposure  
14.28 activities for middle school and high school  
14.29 youth, parents, and counselors to reach a more  
14.30 diverse demographic and broader statewide  
14.31 audience. This requirement includes, but is  
14.32 not limited to, an expansion of programs to  
14.33 provide experience in different crafts to youth  
14.34 and young adults throughout the state;

16.11 hard-to-train individuals. This is a onetime  
16.12 appropriation and funds are available until  
16.13 June 30, 2024.
- 16.14 (t) \$475,000 each year is from the workforce  
16.15 development fund for a grant to Bridges to  
16.16 Healthcare to provide career education,  
16.17 wraparound support services, and job skills  
16.18 training in high-demand health care fields to  
16.19 low-income parents, nonnative speakers of  
16.20 English, and other hard-to-train individuals,  
16.21 helping families build secure pathways out of  
16.22 poverty while also addressing worker  
16.23 shortages in one of Minnesota's most  
16.24 innovative industries. Funds may be used for
