- Assisted Living Licensure was passed in 2019 with broad bipartisan, provider and stakeholder support
- Intent of the law was to set consistent, clear expectations for providers and more protections for residents living in these settings
- Combines housing and services into one license



Two Categories of Licensure

Assisted Living License


- Provides housing and AL services to residents
- May provide AL services to residents with dementia
- Must meet resident's assessed needs
- Diagnosis does not dictate setting
- Prohibited from having a secured dementia care unit

Assisted Living License w/Dementia Care

- Can advertise, market, or promote as providing specialized care for residents with dementia
- Must meet requirements of AL Facility license and requirements of:
 - License
 - Training
 - Programming
- May have a secure dementia care unit




Licensing Numbers by Location

ALFDC - Assisted Living Facility with Dementia Care


PALF – Provisional Assisted Living Facility


Numbers of ALF/ALFDC by Capacity Size - Metro


Numbers of ALF/ALFDC by Capacity Size – Greater MN

MDH's Implementation Steps

- MDH, DHS, and other stakeholders have stayed very connected regarding licensure requirements, and evolving challenges of this new structure
- We continue to think about ways to retain protections for the residents while making the process less burdensome for providers
- MDH continues to communicate through WebEx's, brown bag lunches, and newsletters to help provide guidance and answer questions
 - 28 WebEx presentations & 5 lunch and learn sessions have been held since February 2021
 - Topics include ALL implementation, licensing/renewal process, food code, physical environment, emergency preparedness, and surveys/investigations

Implementation Concerns

- Kitchen and Food Code
- 24-hour awake staffing requirement
- Cost of licensing/renewal, unable to move facility address
- Assisted Living Director requirements
- RN assessments requirements are time consuming
- Reimbursement of CADI, BI, and EW waivered service payments are too low, or assessments are unfair



Top ALF/ALFDC Survey Findings - Large Providers

- Areas of top 5 citations include:
 - Physical environment
 - Examples include: Lack of smoke alarms, broken windows/missing tiles, holes in walls, insect control
 - Incomplete emergency and disaster planning
 - Examples include: Fire drills, evacuation plans, training of staff
 - Food Code violations



Top ALF/ALFDC Survey Findings - Small Providers

- Areas of top 5 citations include:
 - Physical environment
 - Examples include: Lack of smoke alarms, broken windows/missing tiles, holes in walls, insect control

 - Examples include: Fire drills, evacuation plans, training of staff
 - Food Code violations
 - Lack of documentation in employee records
 - Examples include: Training records, background studies



Agency/Board Responsibilities

Department of Human Services/County

- County assessments/service agreements/case manager turnover
- Waivered service payments
- Moratorium exception

Department of Health

- Licensing/enforcement
- Implementation of statutory requirements
- Every 2-year surveys

Board of Examiners of Long-Term Services and Supports (BELTSS)

• Requirements/responsibilities of the assisted living director

MDH Commitment

- MDH is committed to continuing to provide information, education, and to help answer questions about the licensure
- MDH is currently taking the following steps:
 - Learning from other states about how they have approached regulation of small, residential-style settings.
 - Developing an approach for convening conversations with DHS and consumer/provider stakeholders to explore any modifications that might be needed to balance resident needs and provider concerns for small providers.
