**Bill Description**

This bill allows a funds transfer for Independent School District No. 191, Burnsville-Eagan-Savage. The district has excess building lease proceeds available due to decreased need for real property for school purposes. The net proceeds would first be deposited in the debt retirement fund to satisfy any outstanding principal and interest payments on bonds attributable to the lease, and then the remaining net proceeds would be deposited in the district’s general unrestricted fund. In absence of this bill, the funds would go into the district’s operating capital account, a reserve account in the general fund

The transaction(s) will only affect Independent School District No. 191, Burnsville-Eagan-Savage.
