Section 1. Unclassified positions. Removes the reference to Perpich Center for Arts Education.

Effective Date. Makes this section effective June 30, 2022.

Sec. 2. Additional unclassified positions. Removes the reference to Perpich center for Arts Education.

Effective Date. Makes this section effective June 30, 2022.

Sec. 3. Alternative Teacher Compensation Revenue for Multidistrict Integration Collaboratives. Removes the references to Perpich Center for Arts Education.

Effective Date. Makes this section effective June 30, 2022.

Sec. 4. Severance pay. Removes the reference to Perpich Center for Arts Education.

Sec. 5. Severance pay. Removes the reference to Perpich Center for Arts Education.

Sec. 6 [127A.155] Lola and Rudy Perpich Arts Education Specialist.

Subdivision 1. Establishment of arts education specialist position.

Subd. 2. Specialist duties. Paragraph (a) requires the department to provide arts support services throughout Minnesota through the establishment of the Lola and Rudy Perpich arts education specialist position.

Paragraph (b) requires the arts education specialist to offer resources and outreach services throughout Minnesota that will enhance arts education opportunities for both elementary and secondary school students. Requires the arts education specialist to work with school districts in the state to:

- (1) gather and conduct research in arts education;
- (2) develop exemplary curriculum, instructional practices, and assessment;
- (3) disseminate information regarding arts education opportunities; and
- (4) provide materials, training, and assistance to the arts education committees in school districts.

Paragraph (c) requires the arts education specialist to serve as a liaison for the Department of Education to national organizations for arts education.

Paragraph (d) requires the arts education specialist to collaborate with the MacPhail Center for Music to provide online learning instruction to students.

Effective Date. Makes this section effective June 30, 2022.

Sec. 7. Sales to government. Removes the reference to Perpich Center for Arts Education.

Effective Date. Makes this section effective June 30, 2022.

Sec. 8. Included employees. Removes the reference to Perpich Center for Arts Education employees.

Effective Date. Makes this section effective June 30, 2022.

Sec. 9. Teacher. Removes the reference to Perpich Center for Arts Education employees.

Effective Date. Makes this section effective June 30, 2022.

Sec. 10. Perpich Center for Arts Education Closure.

Subd. 1. Perpich Center for Arts Education abolished. Paragraph (a) abolishes the Perpich Center for Arts education effective June 30, 2022. States that the abolishment under this section does not reduce or limit the powers and authority the Perpich Center during the remainder of its existence.

Paragraph (b) states, notwithstanding any other law, unexpended and unencumbered appropriations to the Perpich Center must transfer back to the fund or account from which

they were appropriated from on June 30, 2022. States that all the money in a dedicated fund or account of the Perpich Center on June 30, 2022 must be transferred to the general fund.

Subd. 2. Library. States that all the property in the Perpich Arts Library will be transferred to the State Library Services Division of the Department of Education effective June 1, 2022.

Subd. 3. Student enrollment. States that students enrolled in the Perpich Arts High School during the 2020-2020 school year may continue to enroll in the school for the 2021-2022 school year. States that no student may enroll in the Perpich Arts High School after the 2021-2022 school year.

Subd. 4. Perpich Center property conveyance. Requires the Perpich Center to submit to the legislature by January 15, 2022 a proposal to convey the real and personal property of the Perpich Arts High School to a school district or nonprofit institution. States that if the Perpich Center does not submit a proposal to the legislature, all property shall be transferred to the Department of Administration effective June 30, 2022.

Subd. 5. Education records. Requires the Perpich Center to transfer the education records of each student of the Perpich Arts High School according to **Minnesota Statutes, section 120A.22, subdivision 7.**

Effective Date. Makes this section effective the day following final enactment.

Sec. 11. Appropriations; Department of Education.

Subd. 2. Online access to music education. Paragraph (a) appropriates blank amounts for fiscal year 2022 and fiscal year 2023 from the general fund to the commissioner of education for a grant to the MacPhail Center for Music to broaden access to music education in Minnesota.

Paragraph (b) requires the MacPhail Center to use the grants to broaden access to music education in Minnesota. Requires the MacPhail Center to design its program in consultation with the Department of Education arts education specialist.

Paragraph (c) allows the MacPhail Center to enter into an agreement with a school to provide a program in an early childhood setting upon request from a school's music educator.

Paragraph (d) requires the MacPhail Center to prepare and submit an annual report to the legislature describing the online programs offered, program outcomes, students served, estimate of the unmet needs for music education, and for calendar years 2023 and later, a detailed list of expenditures from the previous year.

Subd. 3. Arts education specialist. Appropriates blank amounts in fiscal year 2022 and fiscal year 2023 from the general fund to the Department of Education for an arts education specialist.

Sec. 12. Appropriations; Perpich Center for Arts Education. Appropriates a blank amount in fiscal year 2022 and \$0 in fiscal year 2023 from the general fund to the Perpich center for Arts Education. States that the base for fiscal year 2024 and later is \$0.

Sec. 13. Repealer. Paragraph (a) Repeals **Minnesota Statutes, sections 124D.8957, subdivision 30; 129C.10, subdivisions 1, 2, 3, 3a, 3b, 4, 4a, 6, 7, and 8; 129C.105; 129C.15; 129C.20; 129C.25; 129C.26; and 129C.27.** Repeals Perpich Center for Arts Education references and authority in statute.

Paragraph (b) Repeals **Minnesota Rules, parts 3600.0010, subparts 1, 2, 2a, 2b, 3, and 6; 3600.0020; 3600.0030, subparts 1, 2, 4, and 6; 3600.0045, subparts 1 and 2; 3600.0055; 3600.0065; 3600.0075; and 3600.0085.** Repeals Perpich Center for Arts Education references and authority in rule.

Effective Date. Makes this section effective June 30, 2022.
