

1.1 Senator moves to amend S.F. No. 5284 as follows:

1.2 Page 120, after line 30, insert:

1.3 "Sec. 132. Laws 2021, First Special Session chapter 5, article 4, section 141, is amended
1.4 to read:

1.5 **Sec. 141. DRIVER'S LICENSE SAME-DAY ISSUANCE PILOT PROJECT.**

1.6 (a) The commissioner of public safety must conduct a same-day driver's license pilot
1.7 project as described in this section. The pilot project must be in the cities of Lakeville and
1.8 Moorhead and include any driver's license agent in either city that requests to participate
1.9 in the pilot project. This section applies to driver's license agents participating in the pilot
1.10 project.

1.11 (b) An applicant who submits a properly completed application for a noncompliant
1.12 driver's license, instruction permit, or identification card must be provided with the license
1.13 or card at the time of the application. The license or card must be processed and produced
1.14 at the site of the application. The applicant must not be required to go to another location
1.15 to receive the license or card. The applicant must not be provided with a temporary license
1.16 or card.

1.17 (c) The commissioner must provide the participating driver's license agents with any
1.18 necessary equipment to process and produce the driver's licenses and identification cards
1.19 on site.

1.20 (d) The design and construction of a noncompliant driver's license, instruction permit,
1.21 or identification card issued under the pilot project must be substantially similar to centrally
1.22 issued drivers' licenses, instruction permits, or identification cards issued under Minnesota
1.23 Statutes, chapter 171.

1.24 (e) A same-day noncompliant driver's license, instruction permit, or identification card
1.25 must, as much as practicable, contain the same security features as centrally issued
1.26 noncompliant drivers' licenses, identification cards, or instruction permits. The security
1.27 features of a same-day noncompliant driver's license, instruction permit, or identification
1.28 card must not obscure the colored photograph of the licensee.

1.29 (f) To the extent practicable, the materials used in printing the noncompliant driver's
1.30 license, instruction permit, or identification card must be substantially similar to and must
1.31 not have significant differences in weight, thickness, or rigidity when compared to centrally
1.32 issued licenses or cards.

2.1 (g) By January 1, ~~2024~~ 2026, the commissioner must submit a report on the pilot project
2.2 to the chairs and ranking minority members of the legislative committees with jurisdiction
2.3 over transportation policy and finance. At a minimum, the report must include the following:

2.4 (1) a description of the pilot project and the locations that participated in the pilot project;

2.5 (2) how many noncompliant drivers' licenses, instruction permits, or identification cards
2.6 were processed during the pilot project;

2.7 (3) any information or feedback from the driver's license agents about the pilot project;

2.8 (4) ~~a~~ an updated recommendation on whether the issuance of same-day noncompliant
2.9 drivers' licenses, instruction permits, or identification cards should be expanded statewide
2.10 or whether the pilot project should be expanded to additional locations across the state; and

2.11 (5) detailed information on the commissioner's implementation of the requirements in
2.12 paragraphs (d) to (f), including a review of security features and a comparison of a centrally
2.13 issued noncompliant driver's license, instruction permit, or identification card versus a
2.14 noncompliant driver's license, instruction permit, or identification card issued under the
2.15 pilot project.

2.16 Sec. 133. Laws 2021, First Special Session chapter 5, article 4, section 141, the effective
2.17 date, is amended to read:

2.18 **EFFECTIVE DATE.** ~~This section is~~ Paragraphs (a) to (c) are effective on October 1,
2.19 2022, and applies apply to applications received on or after that date. Paragraphs (d) to (g)
2.20 are effective August 1, 2024, and apply to applications received on or after that date."
