COMPLAINT TO THE ETHICAL CONDUCT SUBCOMMITTEE REGARDING THE CONDUCT OF SENATOR Mark Johnson

Senator Omar Fateh each being first duly sworn, state and allege under oath the following based upon information and belief:


Complaint: Senator Johnson used a derogatory term for people of Polish descent on the Senate floor at the conclusion of the floor session.

- 1. In the early morning of Wednesday, February 22, 2023, Senator Mark Johnson used a derogatory term for people of Polish descent during the conclusion of the floor session. Senator Johnson stated ""Doesn't matter what your race, your color, your creed, Norwegian, Polack, Somalian, you name it."
- 2. Senate Temporary Rule 56 states that "members shall adhere to the highest standard of ethical conduct...".
- 3. Senate Temporary Rule 56.3 states that "improper conduct includes conduct that... violates accepted norms of Senate behavior, that betrays the public trust, or that tends to bring the Senate into dishonor or disrepute".
- 4. When a Senator uses a derogatory term for a particular group of people, they are egregiously violating the accepted norms of Senate behavior.
- 5. The people of Minnesota expect that Members of the Minnesota Senate adhere to the highest ethical standards. Using a derogatory term on the floor of the Senate damages the reputation of the Senate.
- 6. It is your complainant's belief that Senator Mark Johnson violated Senate Temporary Rule 56.3.
- 7. Your complainant asks that the Ethical Conduct Subcommittee immediately investigates the details of this matter, finds probable cause exists for the violation of Rule 56.3 and that the Committee, in open hearing, recommend appropriate disciplinary action and/or sanction for the violation of our rules.





GOP Politician Uses Polish Slur In Speech Claiming Party Isn't Bigoted

A Minnesota state senator is getting criticized after a speech where he claimed the state's Republican Party isn't bigoted — and included a slur against Polish people in the process.

During a hearing about potential legislation that would allow undocumented immigrants to get ID cards and Class D driver's licenses, Sen. Mark Johnson (R), the Senate Minority Leader, argued that GOP lawmakers had good-faith objections to the bill, according to the Independent.

"There are holes in this bill," Johnson said, while insisting he wasn't attacking any particular demographic groups. "We're not calling groups any names. What we're saying is we need to protect Minnesotans."

However, he may have hurt his cause with his next statement.

"Doesn't matter what your race, your color, your creed, Norwegian, Polack, Somalian, you name it. But folks, we have concerns about this — and yet when we bring those concerns up on this floor, tonight we were called white national racists," he said.

For those who might be unaware, "Polack" has been considered a derogatory term for Polish people for decades, and was most famously spouted by Archie Bunker, a bigoted character in the 1970s sitcom "All in the Family."

In addition, some media have reported that Johnson <u>may have</u> <u>used the word "Somalian"</u> in his speech, though it's not conclusive. The term "Somalian," while not necessarily a slur, is incorrect, as the term "Somali" is preferred.

Of course, many Twitter users found it ironic that a GOP politician used a slur in a speech claiming his party isn't bigoted.

Fellow Minnesota state Sen. Andy Smith (D) said Johnson's

remarks were "telling."
