1.16	organs.

1.19	(2) any facility, regardless of the type of facility and regardless of the facility's license,
1.20	where patient care staff employed by the state provide patient care.
1.21	(f) "Nurse" has the meaning given in section 148.171, subdivision 9, and includes nurses
1.22	employed by the state of Minnesota.
1.23	(g) "Patient" means a patient of a facility.
1.24	(h) "Patient care staff" means a person in a nonsupervisory and nonmanagerial position
1.25	who provides direct care; who provides supportive, rehabilitative, or therapeutic services
1.26	to patients; or who directly provides nursing care to patients more than 60 percent of the
1.27	time, but who is not:
1.28	(1) a licensed physician;
1.29	(2) a physician assistant licensed under chapter 147A; or
1.30	(3) an advanced practice registered nurse licensed under sections 148.171 to 148.285,
1.31	unless working as a registered nurse."
