Bill Description

SF4600 requires the commissioner of labor and industry to engage in rulemaking to lower the acceptable blood lead levels above which require removal of workers from lead exposure and to lower the acceptable blood lead levels required before a worker is allowed to return to work. The thresholds established must be based on the most recent public health information on the safety of lead exposure. The commissioner must consult with the commissioner of health in this rulemaking.

Assumptions

DLI's Minnesota Occupational Safety and Health Administration (MNOSHA) and the Minnesota Department of Health (MDH) would collaborate to change the following current standards:

-the Blood Lead Level (BLL) at which an employee is required to be removed from lead exposure, currently at least 50 µg/dL, for both general industry and construction

-the BLL at which an employee may be returned to work involving lead exposure, currently < 40 μ g/dL for both general industry and construction.

MNOSHA anticipates a medium rule expenditure (\$136,496) associated with this bill.

Several states have updated their Occupational Lead Standards. Michigan OSHA (MIOSHA) was used as a guideline to determine what resources MNOSHA would require implementing the changes required by this bill. MIOSHA has updated their lead standards for both general industry and construction. Their changes included reducing the BLL at which an employee is required to be removed from lead exposure from 50 μ g/dL to 30 μ g/dL for both general industry and construction. MIOSHA also changed the BLL at which an employee may be returned to work involving lead exposure from < 40 μ g/dL to 15 μ g/dL for both general industry and construction standards. MIOSHA's revisions followed recommendations developed by a group of stakeholders over the course of meetings held in 2017 and 2018. The group's proposed revisions to the occupational standards were the subject of public hearings in August 2018 and the rules became final in March 2021.

Considering MIOSHA's experience, an Advisory Committee would need to be established by MNOSHA. The committee would be comprised of representatives from the Minnesota Department of Health, industry, labor, management, MNOSHA Advisory Council Member, and health/medicine. The Advisory Committee would be charged with updating MNOSHA's existing blood lead levels to reflect today's level of public health knowledge. The committee would also research proposals and draft rule revisions for consideration by the Department of Labor and Industry and the Department of Health.

Similar to MIOSHA's process, MNOSHA anticipates six meetings to determine the new proposed levels. Initial steps would include researching existing standards, agreeing on proposed MNOSHA rule changes, creating final draft documents, submitting for promulgation, and likely conducting a public hearing. Like MIOSHA, this process could take as long as 2 years. Six Advisory Committee meetings are project to be needed and may take up to 18 months to complete. It is estimated that it will take an additional four to eight months to complete the rule adoption process, including a public hearing and review of the rule by the Office of Administrative Hearings.

MNOSHA and DLI Office of General Counsel will participate using existing staff with the exception of an Industrial Hygienist 3 position. MNOSHA would need one Industrial Hygienist 3 position for two years to lead the Advisory Committee, gather data, conduct research and analysis, and assist in the completion of the MNOSHA rulemaking process. The position would also inform Federal OSHA of any MN rule changes to ensure that MNOSHA remains as effective as Federal OSHA as required by the federal grant.

Bill Description

SF4600 authorizes the Department of Labor and Industry (DLI) to conduct rulemaking pursuant to Section 1 to lower the threshold of acceptable blood lead levels required for a worker to be removed from the lead exposure and to lower the threshold of acceptable blood lead levels required for a worker to return to work.

Assumptions

The Office of Administrative Hearings (OAH) in consultation with Minnesota Management and Budget (MMB) assesses agencies the cost of services rendered to them. All agencies shall include in their budgets provisions for such assessments.

OAH has used DLI's assumption that a medium rulemaking will be required to meet the requirements of Sec. 1. Based on past practices, OAH assumes that a medium rulemaking under chapter 14 will require an estimated 50 hours of administrative law judge (ALJ) time for activity related to rulemaking procedures. Of the total rulemaking amount of \$136,496 estimated by DLI, \$12,250 is for the 50 hours of ALJ time for a medium rulemaking.

OAH currently bills ALJ time for rulemaking at the MMB-approved billable rate of \$245 per hour (see Minn. Stat. § 16A.126, subd. 1 (2022)).

Expenditure and/or Revenue Formula

Estimated 50 hours of ALJ time for rulemaking activities related to implementing the requirements of Sec. 1 = 50 hours x \$245/hr = \$12,250 charged to DLI in FY2025 pursuant to the requirements of Minn. Stat. § 14.53.

Long-Term Fiscal Considerations

Costs associated with rulemaking activities are a one-time occurrence.

Bill Description

The bill directs the commissioner of labor and industry (DLI), in consultation with the commissioner of health, to adopt rules to lower the blood lead level threshold which would trigger mandatory removal of workers from a worksite with lead exposure and lower the blood lead level threshold where a removed employee is allowed to return to work.

The bill doesn't include an appropriation or effective date.

Assumptions

The department assumes that DLI will lead the rulemaking effort and MDH will provide technical assistance specific to public health information regarding the safety of lead exposure. MN Statute, section 14.125, requires state agencies to publish a notice of intent to adopt new rules within 18 months of the effective date of the law. Because of this, we assume that DLI will need our technical assistance for 18 months to develop these rules.

Technical assistance for rulemaking includes reviewing existing scientific literature on the topic, advising DLI on development of the new, lower regulatory value, participating in the rule advisory committee, and providing technical assistance for comments received during rulemaking process. This type of analysis often requires study beyond typical health analysis, including economic feasibility and risk assessment on a variety of factors. Based on our experience developing regulatory standards for similar regulations and the information DLI gathered from Michigan, which implemented similar rules., we estimate that it will take 0.6 full-time equivalent staff hours over 18 months to complete this work.
