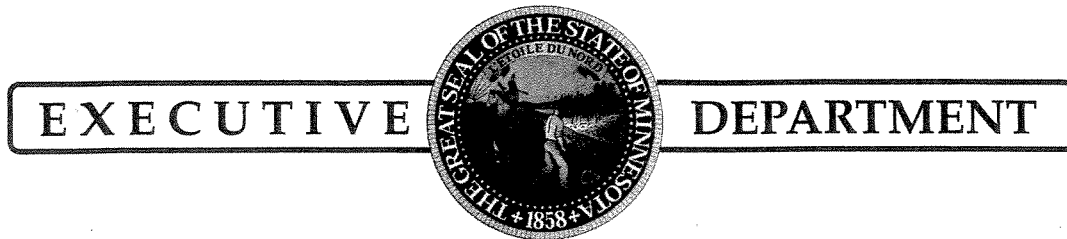

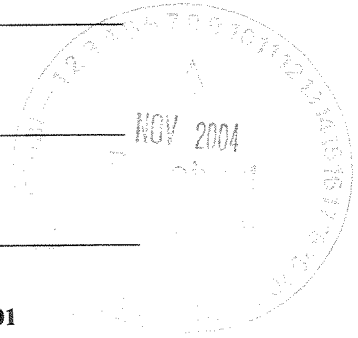

This is a state operated facility serving adolescents from throughout the state of Minnesota who are severely emotionally disturbed.

Shortly after retirement, I successfully completed a 40 hour training program (11/01) becoming Guardian Ad Litem for the Eighth Judicial District primarily Kandiyohi County.
