Peggy Moon served in the United States Air Force from May 1971 until her honorable discharge in May 1974. Following basic training, her entire enlistment was served at Travis Air Force Base, CA, in the Office of Public Relations.

Moon has been a member of The American Legion since her discharge, and has been very active at her home post, Kriesel-Jacobsen Post 560 in Zimmerman, MN. She has served as their Gambling Manager and as their Post Commander. She is active in the Post Honor Guard.

At the District level, Moon served as the Sixth District Commander, 1998-1999. She has also served as Department Vice Commander, 2000-2001. In addition, she has been active on the Post Development Committee and Convention Corporation Committee at the Department level.

Nationally, Moon continues to serve on the Commission of Children and Youth and was elected Vice President for the National Child Welfare Foundation Board of Directors, Oct. 2004 in Indianapolis.

Moon was appointed to the Minnesota Gambling Control Board by Governor Carlson, Dec. 1994, and reappointed by him June 1997. She was reappointed by Governor Ventura July 2001. She served on all Board Committees during this time, and has been the Board Chair since August 1999. Her current term expires June 2005.

She is married to Dr. Carl Moon, Optometrist at the St. Cloud VA Hospital, and has two daughters and two grandchildren. The Moons reside in St. Joseph, MN.
