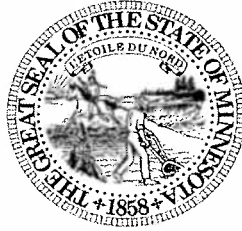

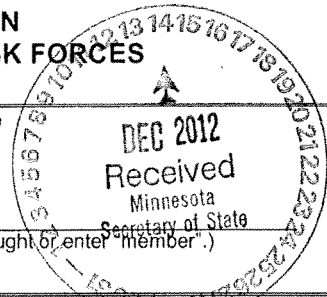

I am on the Mille Lacs Fair Board


I was involved in establishing Snake River Watershed And served on the techical committee and Board of Directors, also involved in establishing Mille Lacs Lake Watershed.
