Dear Governor-Elect Walz:

Congratulations on your election to our state's highest office - a well-deserved honor after a very positive, empowering campaign.

Please consider this cover letter as part of my application to retain my seat on the Workers' Compensation Court of Appeals. I have submitted my updated resume.

As you may recall, during your campaign, my then-law firm invited you to speak at our annual WC seminar in Duluth. The seminar was held around March 15, about a week after I was selected (and about a month before I took the bench) by Governor Dayton for the WCCA position. This selection was made after a thorough and complete review by the Judicial Selection Commission. At the seminar, I was speaking at the podium when you entered the room, and we chatted briefly before you addressed the audience. We discussed that my appointment to the bench came with a risk. I was asked to complete the six year term of Judge Manuel Cervantes, who retired due to medical issues. His term was set to expire on January 7, 2019, so I was essentially appointed to a nine month job, with no guarantees for a subsequent full six year term in light of the pending race for governor. Governor Dayton is precluded by law from re-appointing me in January. That choice is up to you, the new governor. The risk I took included quitting my successful law practice at my firm and selling my house in Duluth, a home I had lived in since 1993. The risk was also taken by my fiancé, who had to quit her job as a research psychologist at the University of Minnesota-Duluth in order to move to St. Paul with me. It took eight U-Haul trucks and learning a new city, but we have enjoyed every moment. We are already feeling very welcome and part of the Lowertown community. I am a huge fan of the light-rail system which brings me to work and takes me home every day.

My resume sets out many of the details of my career before taking the bench. I have a long history of success in the practice of law, public service (through pro bono activities, professional services, and within the legal and Duluth communities), peer

recognition, and leadership. I have been asked numerous times to teach at CLE classes, teach and coach mock trial teams at UMD, serve as an arbitrator, and author amicus curiae briefs. I was asked to serve as an officer and executive with MAJ, and as an Ethics Committee member and Fee Arbitration Chair with the 11th District Bar Association. I spent 13 years coaching kids in soccer, baseball, and softball. My passion for sports has further instilled values of completion and fair play, lessons that go far beyond the playing field or the courtroom.

I believe I am the first and only non-metro lawyer to serve on the WCCA, so I bring that unique perspective to the court. Likewise, there have been very few lawyers who represented real human beings, not corporations, to sit on this court. In the past 25-30 years, I am only one of two judges to sit on the court who had a previous career predominantly representing injured employees. Only after experiencing all that goes into a case, from the initial client meeting, the commencement of the action, trial prep, and trial, can a lawyer understand what an appeal is all about. There was time, money, worry, and for my clients often financial survival. More, as someone who has written many appellate briefs in my career, my experiences representing actual humans brings special qualifications in reading transcripts (depositions, trial testimony, and the like). Nuances of spoken word and non-verbal communication, that are not part of the cold transcript, cannot be fully understood by those who haven't actually represented people at trial. These unique skills are part of the perspective I bring to the court.

Despite this background, I very much understand the difference between advocate and decision maker. Since taking my seat on the court, I have come to love my job, much as I anticipated, and believe I have already gained the respect and friendship of my fellow judges and the entire staff. Going from advocate to arbiter has proven to be an enjoyable challenge.

Before taking the bench, I had a thriving practice in WC for over 25 years and I believe I earned the respect of my peers as one of the leading WC lawyers in the state. The WC law is incredibly complicated, with regular changes to the statutes and rules governing it, and only those with a broad and lengthy career in WC litigation can appreciate it.

Shortly after taking the bench, Chief Judge Patty Milun assigned me the task of authoring two Cdesisions on post-Dykhoff "arising out of" cases. These are some of the more controversial and complicated matters the WC bar has faced in the past five years proud of the work product and the fact that each case was a unanimous 5-0 decision.

My Grandpa Tom Quinn was a union welder at Westinghouse in Pittsburgh. His union activities led to his appearance before the House Un-American Activities Committee (HUAC). He refused to answer the infamous question "are you now, or have you ever been a member of the Communist Party" on 1st and 5th Amendment grounds. He was charged with and then convicted of Contempt of Congress for this refusal. His case went to the Federal District Court where he was convicted, to the Federal Appeals Court, where his case was remanded for a new trial, and then to the Supreme Court. In a 7-2 vote, his conviction was overturned. Quinn v. U.S., 349 U.S. 155, 75 S.Ct. 668 (1955). There is much more to the story of course. The point is that this true life tale inspired my love of law. What I learned is the power of the law to protect the "little guy" against monied and powerful interests. My Grandpa won because the law won. Reason, fairness, and justice prevailed over intolerance and fear. Law effects change and creates equality. Appellate judges work with the law every day. It is what I have always wanted to do.

The day I graduated law school, my mother looked at me and said, "So, you are some big shot lawyer now." I demurred but was happy that my mom was proud of me. Then she said, "Just remember who you are." I have never forgotten that lesson, so simply said, yet so powerful and still burned in my memory. Every one of my clients, every lawyer I sat across the table from, every judge that I appeared in front of, every witness I examined, got the same kindness and courtesy from me that I hope to get from them. This sense has continued during my short time on the court in my relationships with those who work here and those who appear in front of us. I can relate to my "regular people" because I have never considered myself to be anything other than a "regular person" myself.

I have the skills, the desire, the passion, the work ethic, and the legal ethics. All I can do is promise to continue to work hard, work diligently, and show choosing me to continue at my job was justified.
