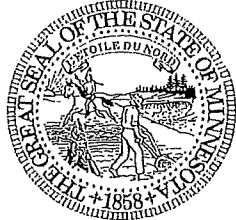

Dear Governor Dayton:

Thank you for considering my application for re-appointment as an At-Large Member of the Board of Trustees of the Minnesota State Colleges and Universities System.

I have appreciated the opportunity to serve on the Board in the last 13 months. I am still learning about the system every day, but I think I have made contributions as a Board Member. I now serve as Vice-Chair of the Audit Committee and member of the Diversity, Equity, and Inclusion Committee. I have good attendance at Board meetings and hopefully I am asking good questions. I have participated in several activities between Board meetings, including interviews of candidates for Chancellor and college president, student organization scholarship fundraisers, and university and college commencements.

Before appointment to the Board, I served as Chair of the Minnesota State Chancellor Search Advisory Committee. Our 19-member committee screened applications, interviewed candidates, and forwarded names to the Chair of the Board of Trustees. It was a great experience for me; I met many capable and interesting people and enjoyed participating in a collaborative process to identify the best candidates to lead the System.

As a proud alumnus of Moorhead State University (now Minnesota State University Moorhead), I am active in supporting the University and its students. I served for several years as a member of the Alumni Foundation Board. I started and financially support a scholarship program for American Indian students at MSUM.

I am by training and experience a trial lawyer. I have tried over 60 civil cases in 19 states, managed national litigation for clients, worked as managing partner of law firms, and served in leadership

positions in bar organizations. My favorite part of being a lawyer is mentoring law students and young lawyers.

Serving my community has been one of my passions my entire career. I have held several Minnesota leadership positions and served on non-profit boards. Most notably, I served as Chair of the Minnesota Commission on Judicial Selection under Governor Ventura. I have served as chair of several other organizations, including the Minnesota American Indian Bar Association, the Civil Litigation Section of the Minnesota State Bar Association, the Minnesota Chapter of the American Board of Trial Advocates, and the Hennepin County Sheriff Foundation.

I am a member of the White Earth Band of Ojibwe; my mother grew up on the Reservation. I am a Justice on the White Earth Tribal Court of Appeals, and I travel to the Reservation quarterly to hear appeals. I also serve as a Court of Appeals Judge for three other Minnesota Tribes: Prairie Island Indian Community, Fond du Lac Band of Lake Superior Chippewa, and Lower Sioux Indian Community. As noted, I have been active in the Minnesota American Indian Bar Association, and I serve on the Board of the Division of Indian Work in Minneapolis.

As a strong proponent of diversity in the legal profession, I have advocated hiring minority lawyers in my law firms and in the community, and I worked for the appointment of minority lawyers as judges. I serve on the Board of the Infinity Project, which promotes gender equity on the bench.

I am by nature collaborative and constructive. I believe that all voices should be heard and decision-makers should work together toward common goals.

If re-appointed, I would continue to strive to serve the best interests of the students in our state colleges and universities. I would work to make an affordable education available to prepare students for good jobs and to be good citizens. Promoting opportunities for American Indian and other minority students is especially important to me. I would like students to have the same opportunity for success that I had as a result of my state university education.
