

It is with great enthusiasm that I apply for the position of metro superintendent representative to the Professional Educator Licensing and Standards Board. As a superintendent who is highly dedicated to the field of education and the quality of the licensed educators, I believe that this opportunity is a strong match for my leadership, vision, experience and skills. I would be honored to be considered for this position.

I have spent my entire career in education and could bring a unique set of experiences to this role. Initially I received my bachelor's degree in Child Psychology and my master's in Educational Psychology with training as a counselor. Using my degrees I began working in private education, filling many roles including that of a non-traditionally prepared teacher and administrator. Looking back, I recognize that my teaching skills needed improvement and could have been supported greatly through added training, experience and licensure in all areas where I worked.

When I went to school to receive my principal license I began to truly understand the importance of training and preparation. My courses trained me to successfully lead schools and I used this knowledge as an international educator in Saudi Arabia before returning to Minnesota as a principal in Saint Paul Public Schools (SPPS). Trying to remediate my own lack of depth of knowledge, I went to every possible Saint Paul teacher training to gain a much deeper understanding of teaching.

Since that time I have participated in a wide range of teacher and administrative licensure, preparation and leadership programs. I served as Director of Leadership Development and Assistant Superintendent for SPPS and worked to create and support the pipeline of diverse, highly prepared school leaders. I oversaw the SPPS Peer Mentor programs, served as a district wide teacher evaluator, led partnerships with teacher preparation programs throughout the metro and helped improve the quality of the licensed SPPS workforce.

As superintendent of Richfield Public Schools I have continued my commitment to supporting and improving the quality of licensed educators. We launched partnerships with local colleges and universities to improve preparation of newly licensed teachers that led to an increase of diversity of our licensed teaching staff of over 4% in this year alone. I have supported the University of Minnesota preparation programs through serving on superintendent licensure panels along with being a frequent speaker in administrative licensure classes.

I believe that my unique set of experiences and preparation make me a highly qualified candidate for this opening on the Professional Educator Licensing and Standards Board. It would be an honor to be chosen to serve the state of Minnesota in our quest to improve the quality, diversity and preparation of our licensed educators.
