I have served on the Minnesota State Arts Board since June 26, 2016 and the term ends January 7, 2019. I would be most grateful to be reappointed for a full term.

This has been a most rewarding and thought-provoking assignment.

As the current Vice Chair of the Board and the Chair of the Outcomes Committee, I have traveled the state to hear directly from citizens, artists, arts producers, economic development agencies, teachers, caregivers, corporations and small businesses. I have learned about the challenges facing artists and the communities they serve \neg and when surmounted, how art can generate and sustain healthy vibrant communities.
