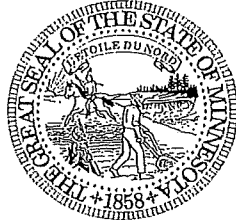

Dr Alex Cirillo was born in Utica, New York. He received his A.B. in Chemistry from The Catholic University of America and both his M.S. and Ph.D. in Chemistry from the University of Wisconsin - Milwaukee Laboratory for Surface Studies. He joined 3M in 1979 as a Senior Physicist. He spent 17 years in the technical organizations of 3M and 14 years in General Management, including R&D Vice President, President and General Manager of 3M Canada, Vice President of Commercial Graphics Division, and Vice President of 3M Community Affairs and the 3M Foundation.

He retired in 2010 and currently serves on the Board of Trustees for the Minnesota State Colleges and Universities, the Board of Directors of the Wilder Foundation, and on the Itasca Project Working Group. He mentors extensively through the Mentium 100 program and Everwise.

In addition to his 3M experience, Dr. Cirillo spent five years in religious life as a teaching Brother and six years in the U.S. Army Reserves. He has taught science and mathematics at various levels from elementary school to university. Dr. Cirillo is an avid guitar player and singer. He and his wife, Judy, have four children and eleven grandchildren.
