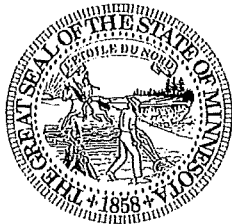

If you have been or are currently employed by a Minnesota school district, please contact the district's local continuing education committee. . If you do not live in Minnesota and have never been employed in Minnesota, you may renew your license by submitting an official transcript verifying 12 quarter or 8 semester credits in the licensure area(s) or in general education courses. These credits must have been earned within the five year period immediately preceding the renewal. . Both of the renewal options indicated above must include the specific professional development requirements in rules that are in effect at the time of renewal. .

Renewal of continuing license/s for superintendents and principals, as well as supervisory and consultative personnel, will require submission of completion certificates verifying 125 clock hours in administrative continuing education programs that have been pre-approved by the Board of School Administrators. Completion certificates or college credits must be submitted with the renewal form and processing fee to Educator Licensing. Dear Governor Walz:

Minnesota Statute 125A.62 allows the Site Councils at the Minnesota State Academies to "...make a recommendation to the governor regarding board appointments no more than 30 days after receiving the list of applicants from the governor." Only one application from a highly competent individual, for each vacant position, was received in seeking the board position of "Special Education Director" and "Member of the Deaf Community". The Site Councils from the MN State Academy for the Blind and the MN State Academy for the Deaf have met and reviewed the applications and decline the option to interview for these positions.

Our recommendation is to appoint Nicole Halabi to the MN State Academies Board for the position of Special Education Director
And to appoint Katherine Wangberg to the MN State Academies Board for the position of Member of the Deaf Community
