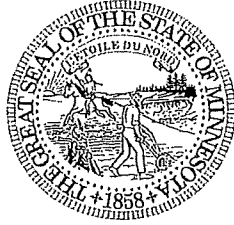

Dear Governor Dayton,

My term as an attorney member of the Minnesota Board on Judicial Standards has expired. This letter is to express my interest in serving another term on the Board.

As noted in my resume, I have been involved in legal ethics for many years. I served on the Third District Ethics Committee of the Office of Lawyers Professional Responsibility from 1994 to 2001. I was chair of the committee from 1998 to 2001. I then served on the Lawyers Professional Responsibility Board from 2001 to 2008. After completion of my term on the LPRB, I rejoined the Third District Ethics Committee for six more years. My work on the DEC was focused on conducting investigations of complaints of attorney misconduct, making recommendations regarding discipline, and participating in discussions and decisions concerning the recommendations of other committee members. My work on the Lawyers Board included considering appeals of disciplinary admonitions and participating in and presiding over panel hearings involving charges of misconduct and petitions for reinstatement to practice. I also served on the Opinions Committee, which reviewed and promulgated opinions interpreting the Rules of Professional Conduct.

I enjoyed very much my work in the area of lawyer ethics. My first term on the Board on Judicial Standards has been equally interesting and enjoyable. The Board strives to promote public confidence in the judicial system and high standards of judicial conduct. I have been an active participant in Board work and have not missed a meeting. I believe other members of the Board would attest to my contributions. I am currently a member of the Executive Committee. I would very much like the opportunity to continue service on the Board and hope you will reappoint me.
