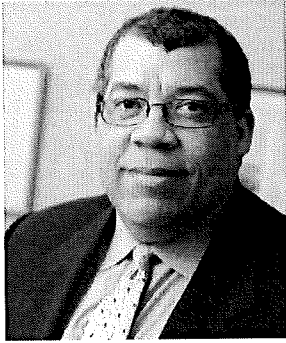

Paul Williams is *President and CEO of Project for Pride in Living (PPL)*, a \$50M multi-service nonprofit helping thousands of low-income individuals and families overcome barriers through affordable housing and job training. With over 1,500 housing units, 200 staff and a broad array of service lines, Paul leads a dynamic and high impact nonprofit that is regarded as one of the region's best. He is a seasoned executive with a strong background in finance, organizational and human capital development, fundraising and community engagement. Paul received his Master's in Nonprofit Management from the *Hubert H. Humphrey School of Public Affairs* and his B.A. in Government from *St. John's University*.

A Trusted Leader at the Local and National Levels

Prior to his service at PPL, Paul was *Deputy Mayor for the City of St. Paul*, serving as lead strategic and operational executive for Minnesota's second largest municipality with an annual budget of \$550M and a staff of 3,000. During 3½ high growth years at the City, Paul led several major initiatives including the successful negotiation of the City's \$63M stadium financing for the award-winning CHS Field, leadership of the City's \$22M business process redesign initiative and creation of the City's first enterprise-wide racial equity initiative.

Paul's diverse career has spanned the government, not-for-profit, foundation and real estate industries, giving him a base of expertise and skills at the local and national levels. He spent nearly a decade in the foundation community, leading innovative grantmaking and investment efforts for *The Minneapolis Foundation, The St. Paul Foundation and the United Way*.

Through this experience, Paul developed a deep expertise in affordable housing, economic development, health and human services and community collaboration. Paul broadened that skill set over the next decade through his role with *Local Initiatives Support Corporation (LISC)*, one of the nation's leading community development financing intermediaries that directs millions of dollars in grant and loan investments to high impact housing and commercial development projects in the Twin Cities and across the nation. Paul directed LISC's investments in the Twin Cities in the late 1990s, eventually moving up to manage LISC's footprint in 30 cities nationwide, a \$75M endeavor.

Organizational Governance & Stewardship

Paul is a gifted leader who has navigated high visibility assignments as both an organizational executive and board leader. Over the years, Paul has been tapped to lead numerous community boards and commissions, including his current role as a *Commissioner and Vice Chair of the St. Paul Port Authority* where he chairs its Credit Committee, helping steward millions in industrial redevelopment activities annually.

Paul also serves as a Commissioner of the *Destination Medical Center*, helping to direct \$580M in public investment as a part of Rochester's \$6B medical sector expansion in partnership with the Mayo Clinic. Paul is also the Vice Chair of the *Minnesota Ballpark Authority*, sitting on its Audit Committee and helping guide the oversight of the \$450M Target Field.

In the philanthropic arena, Paul recently became Chair of *F.R. Bigelow Foundation*, a \$150M private foundation, where he leads their Governance Committee and participates in directing over \$7M in annual grant support to community programs in health and human services, community development and the arts. Paul's deep experience in board governance also includes service on the board and Executive Committee of the *Family Housing Fund*, a \$35M affordable housing lender and grant maker, the *Greater Minneapolis Regional Chamber of Commerce, Mpls. Community & Technical College Foundation* and the *Minneapolis Empowerment Zone*.

In each of these roles, Paul has brought together diverse leaders from the corporate, nonprofit, public and community sectors in working together to ensure strong governance and community impact for those served. Paul's recent work co-chairing the *Itasca Group's North Minneapolis Task Force on Employment* is one such example, as is his leadership on the *Governor's Task Force on Affordable Housing*, a multi-sector committee that made recommendations of strategies to fill the state's critical housing gap. Paul is also comfortable leading in high-visibility, public situations—in 2016, Paul was tapped to Co-Chair the search committee for St. Paul's new *Police Chief*.

Making Organizational and Community Connections

Paul's extensive work with leaders across these diverse sectors is highly regarded. He is a trusted leader who brings rigor, strategic thinking and an astute view of the evolving community marketplace to all of his board assignments. His financial acumen, process skills and ability to bridge institutional and community interests add unique value to the organizations he serves. Paul is skilled at leading through conflict and uncertainty, and is as comfortable in the boardroom as he is out in the community.

Paul is a committed and astute director, a quick study who brings a unique combination of management and operational expertise, and a strong skill set in governance and process leadership.
