2014 – present: Director of Special Education for Hiawatha Valley Education District, Winona, MN
Primary duties include day to day operations for a K-12 Level IV Behavior program including hiring and monitoring of staff, managing behaviors of students, reporting to Minnesota Department of Education on Restrictive Procedures use, and working with parents and teams in the districts. Other duties include Director of Special Education for a small member district, running the Area Learning Center and working with HVED Directors, Special Education Coordinators and itinerant staff, and member district administration to ensure students receive programming they deserve.

2012-2014: Adjunct Professor at the University of Minnesota, Educational Psychology Department/Special Education, Minneapolis, MN

Primary duties include planning and delivery of material for the graduate level course in reading and writing interventions, making data-based decisions for instruction, assessment of student knowledge and guidance of students during their required tutoring sessions.

2009- 2014: Special Education Coordinator, Hiawatha Valley Education District (HVED), Winona, MN

Primary tasks consist of working with the special education staff and administration in 7 rural districts to implement due process procedures correctly. This consists of conducting monthly meeting with staff to update on policies and procedures, problem solve difficult cases and support teachers in compliant IEP writing. Additionally, this position entails collaboration with local district staff and HVED special education administration to promote best practices in design and delivery of instruction for students with disabilities. In conjunction with this position I continue to conduct trainings in SIM strategies and Content Enhancement Routines as well as Crisis Prevention and Intervention (CPI) trainings.

2006-2009: Graduate Assistant Teaching Position, University of MN, Minneapolis, MN

Primary task consisted of planning and delivering instruction to meet the required course components; setting up and maintaining the course website; assessment and grading of student mastery of course requirements, as well as supporting a wide range of student background experiences in the course topics. Additional duties included working with the teacher prep team in completion and submission of the PEPER plan for SLD and EBD programs; review of SLD Master of Education program application files and making recommendations for admission, and advising of students in the SLD program. In addition to teaching duties I was also lead instructor for the Learning Disabilities summer student teaching. This involved planning and delivering weekly seminars on topics such as Due Process, IEP writing, and interventions. This role also included review of the students' final portfolios and determination as to whether the contents met the rigor for licensure eligibility.

2006-present: Teaming with MDE SLD Specialist to write and train district staff and trainers on content from the state SLD Manual

This assignment involved working in partnership with the state SLD specialist to design and write state guidance for implementing IDEIA 2004 and the RTI process for possible eligibility determination. As a part of this work, I was responsible for forming and leading two work groups whose task was to generate content for the manual. Once the manual was posted I was worked with the state SLD specialist and a group of others to develop training content. This content was then piloted by the state SLD specialist and me, with adjustments being made prior to dissemination to districts across the state. On-going content development includes materials for training of local staff and training of trainers modules. Modules are adjusted based on data collected pre/post training sessions.

2002- 2009: Instructional Coach/Consultant, Hiawatha Valley Education District, Winona, MN

Primary tasks consists of planning and providing professional development opportunities for large and small groups of teachers and staff members in the areas of SIM, CBM, CIMP, RTI and Problem Solving procedures; Research based reading, writing and math program development and support as well as implementation of various other researched instructional tools. Other duties include: assisting directors and coordinators with monitoring of Due Process in the various districts; guiding general and special education teachers through data collection and data based decisions; on-going support to teachers of methods and strategies learned in the professional development opportunities. Collection and interpretation of data on implementation of practices and continued needs for supports and professional development was part of this role also.

2003-2006: Adjunct Professor, Winona State University, Winona, MN

2003-04 taught the special education core course for the DCD assessment and methods, and the Inclusion course which included instructional strategies for working with LD students both in an inclusionary and resource setting. 2004-2006 I taught the course Educating Exceptional Children course which is a required course for all education majors and designed as an overview of all of the exceptionalities. Other duties included with working with graduate assistants, some advising of students as well as providing input on the overall program development for special education majors.

1998-2002: Special Education Teacher, Jefferson Elementary School, Winona, MN

Responsible for program planning and instruction of students in the special education program under various eligibility categories; evaluation of new referrals and 3 year mandated evaluations; following all due process for evaluations including involving and reporting results to parents; following all due process requirements for IEP writing and reporting progress to parents; transition planning for students moving on to the Middle School level; ongoing communication with parents and general education teachers; working with and monitoring of paraprofessionals to best meet the needs of the students; membership on and served as chair of the building MEEP and Site teams. Additional accomplishments include: writing and receiving several grants for purchase of a reading curriculum for the special education program; parent involvement grants and the Dare to Dream grant to purchase 4 computers, a laser printer and software for student use.

Responsible for following all due process as described above. Also, included working with and program planning for the physically impaired students. Received training the mobility strategies and assisted PT in training others.
