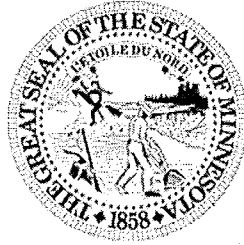

SELECTED ACCOMPLISHMENTS

Policy analysis and development:

- Service as a Minnesota Racing Commissioner. Worked with agency and legislative staff to develop and revise statutes and administrative rules in order to promote and protect the integrity of the horse racing industry. Analyzed industry trends, stakeholder input and regulatory mandates to achieve equitable yet effective policy. Provided industry information to legislative oversight committees.

President of the Senate

Program Implementation:

- Selected to rehabilitate a struggling educational program as Dean of Veterinary Technology for a network of colleges. Completely revised all regulatory systems to meet current requirements. Rewrote USDA animal use protocols. Collaborated with agency officials to ensure DEA compliance. Formulated new curriculum in accordance with programmatic accreditation standards. Dramatically improved outcomes metrics, including an increase of over 30 percentage points in certification exam passing rates in three years, to a point exceeding the national average.
- Instrumental in the start-up of horse racing in Minnesota (1985). Networked with state agencies and educational institutions to implement workable systems for quality assurance and proficiency in drug testing. Coordinated compliance by licensees and involved staff members with all applicable federal and state regulations. Developed relationships with interest groups to facilitate communications. Generated a standard operating procedures manual for sample chain of custody and designed a racing injuries tracking system, both now in use in multiple states.

Research administration:

- Directed equine research fund generated through pari-mutuel racing (over \$ 1,000,000). Implemented a review board utilizing expertise from multiple veterinary colleges. Designed a proposal review system to specifically address scientific merit, cost-effectiveness, and animal usage issues. Successfully negotiated changes in legislation ensuring interim and final results dissemination back to the funding source. The use of these funds stimulated the granting of several million dollars in follow-up funding from external sources to researchers at the University of Minnesota.

Communication:

- Interacted extensively with advisory committees and a variety of private and public agencies on various educational issues, to define processes and negotiate potential solutions. Formulated agendas and managed meetings with multiple remote participants. Collected and analyzed data to gauge effectiveness and worked with stakeholders to revise plans as needed.
- Published a variety of articles on veterinary subjects for lay readership.
- Taught veterinary physiology to adult college students of diverse backgrounds.
- Participated in numerous public meetings involving horse racing issues.
- Provided client education to animal owners while in private practice, to facilitate a basic understanding of health issues and possible treatment choices.

Develop policies and procedures for veterinary care of animals in municipal shelter, including setting up surgical capabilities for sterilization. Work with staff on community outreach to improve health and safety of city animals. Testify at hearings. Hire and train personnel. Monitor in-shelter regulatory matters. Work with other organizations to optimize placements for appropriate animals.

Dear Governor Walz:

I am today submitting my application for re-appointment as a member of the Minnesota Racing Commission (MRC).

As of June I will have served as a Commissioner for thirty years, the last two years as Chair. I came to Minnesota in 1985 to assist with the onset of pari-mutuel racing, working as part of the MRC staff until my initial appointment to the Commission in 1993. I have actually been involved in horse racing in several states for over 50 years in total.

With this background I have a deep understanding of the industry as well as the historical knowledge of MRC activities over the years. I also bring to the Commission a network of strong relationships with various stakeholders and hold their trust.

I believe that my long term involvement with the MRC and my position as Chair have created a sense of security and stability within both the Commission and the racing industry here in Minnesota.

We are in the very early stages of a federal takeover of certain aspects of racing under the umbrella of the Horseracing Integrity and Safety Act (HISA). While I believe that uniform standards across the country are well overdue I also know that change is never easy. Minnesota's racing rules and systems helped serve as a model for many of HISA's regulations but we are still looking at several years of difficulty working through the myriad of details that will be involved

For these reasons I strongly believe that my reappointment as a Commissioner and as Chair would be in the best interests of the MRC and the horse racing industry in this state. I appreciate your consideration.
