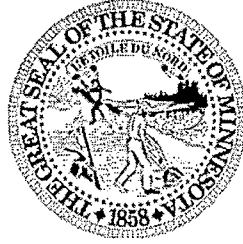

Resume for Steven K. Anderson

I have a B.S. in Music Education from North Dakota State University and a M.A. in Tuba Performance from St Cloud State University. I taught public school for 4 years in small towns in North Dakota (Newburg) and northwestern Minnesota (Kennedy). I have conducted a Jazz Band and taught guitar lessons at Northland Community College in Thief River Falls for 3 years. In 1991 I moved to Brainerd and founded the Instrumental Music Department at Central Lakes College and taught there until my retirement in May of 2018. During that time, I built the Community Band and Jazz Band into regular performing groups taking the Community Band on 3 overseas tours in 2011, 2014 and 2017 performing concerts in Prague, Vienna, Budapest, London, York, Edinburgh, Dublin, Galway, Cork and other cities in Ireland.

While at Central Lakes College, I taught Music Theory, Evolution of Jazz, Music and World Cultures, Popular Music History Audio Recording and Music Industry both face to face and online. I wrote the content for several of these classes. I also conducted the pit orchestra for 12 Theater Department musicals including "The Who's rock Opera tommy", "The Sound of Music", "Jesus Christ Superstar", "Hello Dolly", "Chicago", "Funny Thing Happened On the Way To the Forum", "Rocky Horror", "Godspell", "Spamalot", and "Young Frankenstein". In addition to the teaching duties I also participated with my groups in the Minnesota Fine Arts Festival every year until it's demise in 2014. I managed the festival 9 of the last 10 years of it's existence.

During my time as a teacher, I also kept up a regular performing career as a solo musician in nightclubs and supper clubs in a four state area from Wisconsin to Montana with the last 20 years limiting my performances to the Brainerd Lakes area.

I am currently retired but still conducting the Wadena Area Community Band, performing in resort venues in the Brainerd Lakes area and playing in the Central Lakes College Jazz Band and Wind Symphony.
