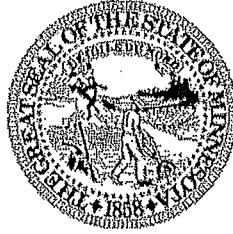

## Biography of James R. Campbell

Jim retired in 2002 completing a 38 year financial services career. He and his wife Carmen spend the winters in Naples, FL and the summers in Minnesota.

After graduating from the University of Minnesota, Jim joined the Northwestern National Bank of Minneapolis beginning as a commercial lending trainee. In 1979 he moved to Omaha, NE to become the President of the holding company's bank there, returning to Minneapolis to lead the flagship bank in 1984. In 1988 he became President and CEO of Norwest Bank Minnesota and Executive Vice President of Norwest Corporation. Upon the acquisition of Wells Fargo by Norwest he was named Group Executive Vice President of Wells Fargo and Company.

He has served on several Boards of Directors for public and private companies including the Marvin Companies, Lifetouch, Inc., Allianz Life Insurance Company, Fireman's Fund and Merrill Corporation. He also Chaired the Board of the UnitedHealth Foundation and currently serves on the Boards of Artis-Naples, the Destination Medical Center Corporation in Rochester, MN and the Minnesota Ballpark Authority, the home of the Minnesota Twins.

Jim has been extensively involved in many community, non-profit and educational organizations. He was the Chairman of the Board of the University of Minnesota Foundation and is a Life Trustee. He also served as an interim Dean of the Carlson School of Management at the University. He chaired the Boards of the Greater Twin Cities United Way and the Abbott-Northwestern Hospital. He has served on the Boards of the Minneapolis Institute of Arts, Allina Health, Junior Achievement, the Minneapolis Foundation, Children's Home Society and Westminster Presbyterian Church

He is the recipient of the Outstanding Achievement and Regents Award and an Honorary Doctor of Laws Degree from the University of Minnesota, the Renaissance Award from the College of Saint Benedict, a Lifetime Achievement Award from the NAACP, and the 2003 Executive of the Year from the Twin Cities Business Journal. In 2005, he was inducted into the Minnesota and Junior Achievement Halls of Fame.
