## Senator Frentz from the Committee on Energy, Utilities, Environment, and Climate, to which was referred

**S.F. No. 747:** A bill for an act relating to prevailing wages; requiring prevailing wage agreements for projects funded in whole or in part with renewable development account funds; amending Minnesota Statutes 2022, section 116C.779, subdivision 1.

Reports the same back with the recommendation that the bill be amended as follows:

Page 5, delete lines 28 and 29 and insert:

"(v) Construction projects receiving funds from this account are subject to the requirement of paying the prevailing wage as defined in section 177.42 and the requirements and enforcement provisions in sections 177.27, 177.30, 177.32, 177.41 to 177.435, and 177.45."

And when so amended the bill do pass and be re-referred to the Committee on Labor. Amendments adopted. Report adopted.

## Senator Frentz from the Committee on Energy, Utilities, Environment, and Climate, to which was referred

**S.F. No. 1180:** A bill for an act relating to public buildings; appropriating money for research to integrate weather trends in designing and operating public buildings to reduce operational costs and prevent damage from extreme weather events; requiring a report.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

## "Section 1. APPROPRIATION; IMPACTS OF FUTURE WEATHER TRENDS ON PUBLIC INFRASTRUCTURE NEEDS AND DESIGN.

- (a) \$690,000 in fiscal year 2024 is appropriated from the general fund to the commissioner of administration to contract with the Board of Regents of the University of Minnesota for a grant to the Institute on the Environment to conduct research examining how projections of future weather trends may exacerbate conditions such as drought, elevated temperatures, and flooding that:
- (1) can be integrated into the design and evaluation of buildings constructed by the state of Minnesota and local units of government so as to:
- (i) reduce energy costs by deploying cost-effective energy efficiency measures, innovative construction materials and techniques, and renewable energy sources; and
- (ii) prevent and minimize damage to buildings caused by extreme weather conditions, including but not limited to increased frequency of intense precipitation events and tornadoes, flooding, and elevated temperatures; and
- (2) may weaken the ability of natural systems to mitigate those conditions to the point where human intervention in the form of the building of, or the redesign of the scale and operation of, infrastructure is required to address those conditions in order to:
  - (i) maintain and increase the amount and quality of food and wood production;
  - (ii) reduce fire risk on forested land;
  - (iii) maintain and enhance water quality; and
  - (iv) maintain and enhance natural habitats.
- (b) The contract must provide that, no later than February 1, 2025, the director of the Institute on the Environment, or the director's designee, submit a written report to the chairs and ranking minority members of the legislative committees with primary jurisdiction over environment policy and capital investment summarizing the findings and recommendations of the research, including any recommendations for policy changes or other legislation.

## **EFFECTIVE DATE.** This section is effective the day following final enactment."

## "Section 1. [256.9756] CAREGIVER RESPITE SERVICES GRANTS.

Subdivision 1. Caregiver respite grant program established. The commissioner of human services must establish a caregiver respite services grant program to increase the availability of respite services for family caregivers of people with dementia and older adults and to provide information, education, and training to respite caregivers and volunteers regarding caring for people with dementia. From the funds made available for this purpose, the commissioner must award grants on a competitive basis to respite service providers, giving priority to areas of the state where there is a high need of respite services.

- Subd. 2. **Eligible uses.** Grant recipients awarded grant funding under this section must use a portion of the grant award as determined by the commissioner to provide free or subsidized respite services for family caregivers of people with dementia and older adults.
- Subd. 3. Report. By January 15, 2026, and every other January 15 thereafter, the commissioner shall submit a progress report about the caregiver respite services grants in this section to the chairs and ranking minority members of the legislative committees and divisions with jurisdiction over human services. The progress report must include metrics of the use of the grant program funds."

Page 2, delete section 2 and insert:

# "Sec. 3. <u>DIRECTION TO COMMISSIONER OF HUMAN SERVICES; CAREGIVER</u> RESPITE SERVICES GRANTS.

Beginning in fiscal year 2025, the commissioner of human services must continue the respite services for older adults grant program established under Laws 2021, First Special Session chapter 7, article 17, section 17, subdivision 3, under the authority granted under Minnesota Statutes, section 256.9756. The commissioner may begin the grant application process for awarding grants under Minnesota Statutes, section 256.9756, during fiscal year 2024 in order to facilitate the continuity of the grant program during the transition from a temporary program to a permanent one.

## Sec. 4. APPROPRIATION; CAREGIVER RESPITE SERVICES GRANTS.

\$2,000,000 in fiscal year 2025 is appropriated from the general fund to the commissioner of human services for caregiver respite services grants under Minnesota Statutes, section 256.9756."

  - (ii) indicate a desire to make an anatomical gift under subdivision 3b, paragraph (e);
- (iii) as applicable, designate document retention as provided under section 171.12, subdivision 3c; and

- (iv) indicate emergency contacts as provided under section 171.12, subdivision 5b; and
- (6) meet the requirements under section 201.161, subdivision 3.
- (b) Applications must be accompanied by satisfactory evidence demonstrating:
- (1) identity, date of birth, and any legal name change if applicable; and
- (2) for driver's licenses and Minnesota identification cards that meet all requirements of the REAL ID Act:
- (i) principal residence address in Minnesota, including application for a change of address, unless the applicant provides a designated address under section 5B.05;
  - (ii) Social Security number, or related documentation as applicable; and
  - (iii) lawful status, as defined in Code of Federal Regulations, title 6, section 37.3.
- (c) An application for an enhanced driver's license or enhanced identification card must be accompanied by:
- (1) satisfactory evidence demonstrating the applicant's full legal name and United States citizenship; and
  - (2) a photographic identity document.
- (d) A valid Department of Corrections or Federal Bureau of Prisons identification card containing the applicant's full name, date of birth, and photograph issued to the applicant is an acceptable form of proof of identity in an application for an identification card, instruction permit, or driver's license as a secondary document for purposes of Minnesota Rules, part 7410.0400, and successor rules."

  - (3) is in packaging that has been opened or the seal has been broken; or
  - (4) is in packaging of which the contents have been partially removed.
- Subd. 4. Liability of nonpresent owner; crime described. It is a crime for the owner of any private motor vehicle or the driver, if the owner is not present in the motor vehicle, to keep or allow to be kept in a motor vehicle when the vehicle is on a street or highway any cannabis flower, a cannabinoid product, or any product containing an artificially derived cannabinoid that:
- (1) is in packaging or another container that does not comply with the relevant packaging requirements in chapter 152 or 342;
  - (2) has been removed from the packaging in which it was sold;
  - (3) is in packaging that has been opened or the seal has been broken; or
  - (4) is in packaging of which the contents have been partially removed.
- Subd. 5. Criminal penalty. A person who violates subdivision 2, 3, or 4 is guilty of a misdemeanor.

- Subd. 6. Exceptions. (a) This section does not prohibit the possession or consumption of cannabis flower or a cannabinoid product or any other product containing an artificially derived cannabinoid by passengers in:
- (1) a bus that is operated by a motor carrier of passengers as defined in section 221.012, subdivision 26;
- (2) a vehicle that is operated for commercial purposes in a manner similar to a bicycle as defined in section 169.011, subdivision 4, with five or more passengers who provide pedal power to the drive train of the vehicle; or
  - (3) a vehicle providing limousine service as defined in section 221.84, subdivision 1.
- (b) Subdivisions 3 and 4 do not apply to: (1) a package that is in the trunk of the vehicle if the vehicle is equipped with a trunk; or (2) a package that is in another area of the vehicle not normally occupied by the driver and passengers if the vehicle is not equipped with a trunk. A utility compartment or glove compartment is deemed to be within the area occupied by the driver and passengers.

**EFFECTIVE DATE.** This section is effective August 1, 2023, and applies to crimes committed on or after that date."

when tested against laboratory results, how often participants were found to have controlled substances or intoxicating substances in their systems, how often there was commingling of controlled substances or intoxicating substances with alcohol, the types of controlled substances or intoxicating substances found in participants' systems and which types were most common, and the number of participants in the project. In addition, the report must assess the practicality and reliability of using the instruments in the field and make recommendations on continuing the project permanently.

Each January of an even numbered year, the secretary of state must award a Democracy Cup to a postsecondary institution with the highest voting rate according to the National Study for Learning, Voting, and Engagement at Tufts University in each of the following categories: (1) public two-year colleges, (2) public four-year state universities, (3) the University of Minnesota system, and (4) Minnesota private colleges."

  - "Sec. 4. Minnesota Statutes 2022, section 201.1611, subdivision 1, is amended to read:
- Subdivision 1. **Forms.** (a) All postsecondary institutions that enroll students accepting state or federal financial aid shall <u>must</u> provide voter registration forms to each student as early as possible in the fall quarter during the fall and spring of each year. In state election years, it must be provided 15 days in advance of the deadline for registering to vote for the state general election. If the voter registration forms are provided electronically, the electronic message must be devoted exclusively to voter registration.
- (b) All school districts shall must make available voter registration applications each May and September to all students registered as students of the school district who will be eligible to vote at the next election after those months. A school district has no obligation to provide voter registration applications to students who participate in a postsecondary education option program or who otherwise reside in the district but do not attend a school operated by the district. A school district fulfills its obligation to a student under this section if it provides a voter registration application to the student one time.
- (c) The <u>voter registration</u> forms must contain spaces for the information required in section 201.071, subdivision 1, and applicable rules of the secretary of state. The institutions and school districts may request these forms from the secretary of state. Institutions shall <u>must</u> consult with their campus student government in determining the most effective means of distributing the forms and in seeking to facilitate election day registration of students under section 201.061, subdivision 3. School districts must advise students that completion of the voter registration application is not a school district requirement.
- (d) The institutions and school districts must report to the secretary of state by November 30 of each year on their implementation of this section. At a minimum, the report must include how and when the forms were distributed, how many were distributed, and how many were completed.

<u>Institutions</u> and school districts may include information about methods that were effective in increasing student registrations.

- (b) All postsecondary institutions that enroll students accepting state or federal financial aid must designate a staff person as the campus vote coordinator. The campus vote coordinator must:
  - (1) ensure the institution complies with this section;
- (2) report the number of physical and electronic voter registrations collected on an annual basis on the institution's voting website; and
- (3) consult with the campus student association to develop a voter engagement plan that identifies goals and activities, resources to accomplish the identified goals and activities, and individual or key departments responsible for executing the identified goals and activities."
