Referred to the Committee on Rules and Administration for comparison with S.F. No. 170, now on General Orders.

**H.F. No. 871:** A bill for an act relating to municipalities; authorizing city purchases on credit cards; providing for personal liability for city officers and employees for unauthorized credit card purchases; proposing coding for new law in Minnesota Statutes, chapter 471.

Referred to the Committee on State and Local Government Operations.

(b) For the purposes of this definition, the antlers or skulls may be measured at any time; no drying period is required.

Subdivision 1. [SEIZURE.] (a) An enforcement officer must seize all motor vehicles used to:

- (1) shine wild animals in violation of section 97B.081, subdivision 1;
- (2) transport big game animals illegally taken or fur-bearing animals illegally purchased; or
- (3) transport minnows in violation of section 97C.501, 97C.515, or 97C.525.

(b) An enforcement officer must seize all boats and motors used in netting fish on Lake of the Woods, Rainy Lake, Lake Superior, Namakan Lake, and Sand Point Lake in violation of licensing or operating requirements of section 97A.475, subdivision 31, 32, 33, ~~or 37~~ 30, 97C.825, 97C.831, or 97C.835, or a rule of the commissioner relating to these provisions.

(c) An enforcement officer may seize all motor vehicles, including boats and motors with their trailers, that are used to take, possess, or transport a first or second degree gross overlimit of wild animals under section 97A.338.

Subd. 5. [GROSS OVERLIMIT; JOINT AND SEVERAL LIABILITY.] When two or more people intentionally aid, advise, counsel, conspire with, or act in concert with each other to

unlawfully take, transport, or possess a gross overlimit of wild animals, under section 97A.338, each person is jointly and severally liable for the wild animals for purposes of:

- (1) license seizure and revocation under sections 97A.420 and 97A.421;

- (4) restitution under section 97A.341.

Sec. 6. [97A.338] [GROSS OVERLIMITS OF WILD ANIMALS; PENALTY.]

Subdivision 1. [FIRST DEGREE GROSS OVERLIMIT VIOLATION.] A person who takes, possesses, or transports wild animals over the legal limit, in closed season, or without a valid license, when the restitution value of the wild animals is \$5,000 or more, is guilty of a first degree gross overlimit violation.

Subd. 2. [SECOND DEGREE GROSS OVERLIMIT VIOLATION.] A person who takes, possesses, or transports wild animals over the legal limit, in closed season, or without a valid license, when the restitution value of the wild animals is at least \$1,500 but less than \$5,000, is guilty of a second degree gross overlimit violation.

Subdivision 1. [LIABILITY FOR RESTITUTION.] A person who kills, injures, or possesses a wild animal in violation of the game and fish laws is liable to the state for the value of the wild animal as provided in this section. Species afforded protection include members of the following groups as defined by statute or rule: game fish, game birds, big game, small game, fur-bearing animals, minnows, and threatened and endangered animal species. Other animal species may be added by rule of the commissioner as determined after public meetings and notification of the chairs of the environment and natural resources committees in the senate and house of representatives.

Sec. 8. Minnesota Statutes 2000, section 97A.345, is amended to read:

97A.345 [RESTITUTION VALUE OF WILD ANIMALS.]

- (16) canvasback, \$100;
- (17) geese, \$50;
- (18) tundra swan, \$200; and
- (19) trumpeter swan, \$1,200.

Subd. 3. [BIG GAME ANIMALS.] (a) Except as provided in paragraph (b), the restitution values for big game species are as follows:

- (1) deer, \$500;
- (2) elk, \$1,000;
- (3) caribou, \$1,000;
- (4) moose, \$1,000;
- (5) pronghorn antelope, \$500; and
- (6) black bear, \$400.

(b) The restitution values for deer, elk, moose, and bear may be increased to twice the amount listed in this subdivision if the animal is a trophy animal.

Subd. 4. [SMALL GAME.] The restitution values for small game species other than game birds are as follows:

- (1) cottontail rabbit, \$20;

- (13) beaver, \$30;
- (14) muskrat, \$30;
- (15) opossum, \$30;
- (16) bobcat, \$100;
- (17) lynx, \$500; and
- (18) cougar, \$1,000.

Subd. 5. [ENDANGERED ANIMAL SPECIES.] The restitution values for endangered animal species are as follows:

- (1) mammals and birds, \$4,000; and
- (2) all other animals, \$2,000.

Subd. 6. [THREATENED ANIMAL SPECIES.] The restitution values for threatened animal species are as follows:

- (1) mammals and birds, \$2,000; and
- (2) all other animals, \$500.

Subd. 7. [GRAY WOLVES.] The restitution value for gray wolves is \$1,400.

Subd. 8. [FISH.] (a) Except as provided in subdivision 9 for fish species that do not have a designated quality size, or for fish that have a total length equal to or less than the designated quality size, the restitution value is the base value shown in the following table. For fish that have a length that exceeds the designated quality size, the restitution value is the base value plus \$10 for every inch over the quality size.

(b) The restitution values for muskellunge are as follows:

- (1) 0 to less than 30 inches, \$40;
- (2) 30 to less than 40 inches, \$200;
- (3) 40 to less than 50 inches, \$500; and
- (4) 50 inches and over, \$1,000 plus \$100 for each inch over 50 inches.

Subd. 9. [FINGERLINGS.] The restitution value for fish listed in subdivision 8 that are less than four inches in length is \$1 per fish.

Subd. 10. [MINNOWS.] The restitution values for minnows are as follows:

- (1) cyprinidae, fair market value at time of violation;
- (2) umbridae, 50 cents a pound;
- (3) catostomidae, 50 cents a pound;

- (4) bullhead (seven inches or less), 50 cents a pound;
- (5) cisco (seven inches or less), 50 cents a pound;
- (6) lake white fish (seven inches or less), \$1 a pound;
- (7) goldeyes and mooneyes (seven inches or less), 50 cents a pound; and
- (8) leeches, fair market value at time of violation.

Sec. 9. [97A.420] [SEIZURE OF LICENSES FOR GROSS OVERLIMIT VIOLATIONS.]

Subdivision 1. [SEIZURE.] (a) An enforcement officer shall immediately seize the license of a person who unlawfully takes, transports, or possesses wild animals when the restitution value of the wild animals exceeds \$500. Except as provided in subdivisions 2, 4, and 5, the person may not obtain any license to take the same type of wild animals involved, including a duplicate license, until an action is taken under subdivision 6.

(b) In addition to the license seizure under paragraph (a), if the restitution value of the wild animals unlawfully taken, possessed, or transported is \$1,500 or more, all other game and fish licenses held by the person shall be immediately seized. Except as provided in subdivision 2, 4, or 5, the person may not obtain any game or fish license or permit, including a duplicate license, until an action is taken under subdivision 6.

(c) A person may not take wild animals covered by a license seized under this subdivision until an action is taken under subdivision 6.

Subd. 2. [ADMINISTRATIVE REVIEW.] (a) At any time after the seizure of a license under subdivision 1 and before revocation under section 97A.421, a person may request in writing a review of the seizure under this section. Upon receiving the request for review, the commissioner shall review the seizure, the evidence upon which it was based, and other material information brought to the attention of the commissioner, and determine whether sufficient cause exists to sustain the seizure.

(b) Within 15 days after receiving the request for administrative review, the commissioner shall issue a written report of the review and shall order that the seizure be either sustained or rescinded.

(c) The review provided in this subdivision is not subject to the contested case provisions of the Administrative Procedure Act under chapter 14. The availability of administrative review does not have an effect upon the availability of judicial review under this section.

Subd. 3. [JUDICIAL REVIEW.] (a) Within 30 days following the seizure of a license under subdivision 1, a person may petition the court for review. The petition must be filed with the district court administrator in the county where the incident occurred, together with proof of service of a copy on the commissioner and the county attorney. A responsive pleading is not required of the commissioner of natural resources, and court fees may not be charged for the appearance of the representative of the commissioner in the matter.

(b) The petition must be captioned in the name of the person making the petition as petitioner and the commissioner as respondent. The petition must state specifically the grounds upon which the petitioner seeks rescission of the license seizure.

(c) The filing of the petition does not stay the license seizure. The judicial review shall be conducted according to the Rules of Civil Procedure.

Subd. 4. [HEARING.] (a) A hearing under subdivision 3 must be before a district court judge in the county where the incident occurred giving rise to the license seizure. The hearing must be to the court and may be conducted at the same time as hearings upon pretrial motions in a related criminal prosecution. The hearing must be recorded. The commissioner must be represented by the county attorney.

(b) The hearing must be held at the earliest practicable date and in any event no later than 60 days following the filing of the petition for review.



(c) The scope of the hearing must be limited to the issue of whether the officer had probable cause to believe that the person violated section 97A.338.

(d) The court shall order that the license seizure be either sustained or rescinded. Within 14 days following the hearing, the court shall forward a copy of the order to the commissioner.

(e) Any party aggrieved by the decision of the reviewing court may appeal the decision as provided in the Rules of Civil Appellate Procedure.

Subd. 5. [TEMPORARY RELEASE OF COMMERCIAL LICENSES.] At any time during the period that a game or fish license is seized under subdivision 1, a person possessing a commercial license issued under the game and fish laws may make a written request to the commissioner to temporarily release the commercial license. If the commissioner determines that the public welfare will not be injured, the commissioner may temporarily reinstate the commercial license upon payment of a temporary reinstatement fee of \$1,000 for each commercial license to be released. If the license is returned under subdivision 6, paragraph (a), the temporary reinstatement fee shall be returned to the licensee. If the license is revoked under subdivision 6, paragraph (b), the temporary reinstatement fee shall be deposited in the game and fish fund and is not refundable.

Subd. 6. [RETURN OR REVOCATION OF LICENSES UPON DISMISSAL OR CONVICTION.] (a) Upon acquittal, dismissal, or determination not to charge a person for a gross overlimit violation under section 97A.338, the license seizure under subdivision 1 is immediately rescinded and any license seized in connection with the incident must be returned to the licensee.

(b) Upon conviction of a gross overlimit violation under section 97A.338, revocation of licenses and license privileges must be imposed as provided under section 97A.421, subdivision 2a.

Sec. 10. Minnesota Statutes 2000, section 97A.421, is amended by adding a subdivision to read:

Subd. 2a. [ISSUANCE OF LICENSE AFTER GROSS OVERLIMIT CONVICTION.] (a) A person may not obtain a license to take a wild animal and is prohibited from taking wild animals for a period of ten years after the date of conviction of the first degree overlimit violation under section 97A.338, subdivision 1.

(b) A person may not obtain a license to take a wild animal and is prohibited from taking wild animals for a period of five years after the date of conviction of the second degree overlimit violation under section 97A.338, subdivision 2.

(c) A person may not obtain a license to take the type of wild animals involved in a third degree overlimit violation under section 97A.338, subdivision 3, and is prohibited from taking the type of wild animals involved in the violation for a period of three years after the date of conviction of the third degree overlimit violation.

Subdivision 1. [GROUNDS LISTED.] The board may refuse to grant a license or may impose disciplinary action as described in section 147.141 against any physician. The following conduct is prohibited and is grounds for disciplinary action:

(a) Failure to demonstrate the qualifications or satisfy the requirements for a license contained in this chapter or rules of the board. The burden of proof shall be upon the applicant to demonstrate such qualifications or satisfaction of such requirements.

(b) Obtaining a license by fraud or cheating, or attempting to subvert the licensing examination process. Conduct which subverts or attempts to subvert the licensing examination process includes, but is not limited to: (1) conduct which violates the security of the examination materials, such as removing examination materials from the examination room or having unauthorized possession of any portion of a future, current, or previously administered licensing examination; (2) conduct which violates the standard of test administration, such as communicating with another examinee during administration of the examination, copying another examinee's answers, permitting another examinee to copy one's answers, or possessing unauthorized materials; or (3) impersonating an examinee or permitting an impersonator to take the examination on one's own behalf.

(c) Conviction, during the previous five years, of a felony reasonably related to the practice of medicine or osteopathy. Conviction as used in this subdivision shall include a conviction of an offense which if committed in this state would be deemed a felony without regard to its designation elsewhere, or a criminal proceeding where a finding or verdict of guilt is made or returned but the adjudication of guilt is either withheld or not entered thereon.

(d) Revocation, suspension, restriction, limitation, or other disciplinary action against the person's medical license in another state or jurisdiction, failure to report to the board that charges regarding the person's license have been brought in another state or jurisdiction, or having been refused a license by any other state or jurisdiction.

(e) Advertising which is false or misleading, which violates any rule of the board, or which claims without substantiation the positive cure of any disease, or professional superiority to or greater skill than that possessed by another physician.

(f) Violating a rule promulgated by the board or an order of the board, a state, or federal law which relates to the practice of medicine, or in part regulates the practice of medicine including without limitation sections 148A.02, 609.344, and 609.345, or a state or federal narcotics or controlled substance law.

(g) Engaging in any unethical conduct; conduct likely to deceive, defraud, or harm the public, or demonstrating a willful or careless disregard for the health, welfare or safety of a patient; or medical practice which is professionally incompetent, in that it may create unnecessary danger to any patient's life, health, or safety, in any of which cases, proof of actual injury need not be established.

(h) Failure to supervise a physician's assistant or failure to supervise a physician under any agreement with the board.

(i) Aiding or abetting an unlicensed person in the practice of medicine, except that it is not a

violation of this paragraph for a physician to employ, supervise, or delegate functions to a qualified person who may or may not be required to obtain a license or registration to provide health services if that person is practicing within the scope of that person's license or registration or delegated authority.

(j) Adjudication as mentally incompetent, mentally ill or mentally retarded, or as a chemically dependent person, a person dangerous to the public, a sexually dangerous person, or a person who has a sexual psychopathic personality by a court of competent jurisdiction, within or without this state. Such adjudication shall automatically suspend a license for the duration thereof unless the board orders otherwise.

(k) Engaging in unprofessional conduct. Unprofessional conduct shall include any departure from or the failure to conform to the minimal standards of acceptable and prevailing medical practice in which proceeding actual injury to a patient need not be established.

(l) Inability to practice medicine with reasonable skill and safety to patients by reason of illness, drunkenness, use of drugs, narcotics, chemicals or any other type of material or as a result of any mental or physical condition, including deterioration through the aging process or loss of motor skills.

(m) Revealing a privileged communication from or relating to a patient except when otherwise required or permitted by law.

(n) Failure by a doctor of osteopathy to identify the school of healing in the professional use of the doctor's name by one of the following terms: osteopathic physician and surgeon, doctor of osteopathy, or D.O.

(o) Improper management of medical records, including failure to maintain adequate medical records, to comply with a patient's request made pursuant to section 144.335 or to furnish a medical record or report required by law.

(p) Fee splitting, including without limitation:

(1) paying, offering to pay, receiving, or agreeing to receive, a commission, rebate, or remuneration, directly or indirectly, primarily for the referral of patients or the prescription of drugs or devices;

(2) dividing fees with another physician or a professional corporation, unless the division is in proportion to the services provided and the responsibility assumed by each professional and the physician has disclosed the terms of the division;

(3) referring a patient to any health care provider as defined in section 144.335 in which the referring physician has a significant financial interest unless the physician has disclosed the physician's own financial interest; and

(4) dispensing for profit any drug or device, unless the physician has disclosed the physician's own profit interest.

The physician must make the disclosures required in this clause in advance and in writing to the patient and must include in the disclosure a statement that the patient is free to choose a different health care provider. This clause does not apply to the distribution of revenues from a partnership, group practice, nonprofit corporation, or professional corporation to its partners, shareholders, members, or employees if the revenues consist only of fees for services performed by the physician or under a physician's direct supervision, or to the division or distribution of prepaid or capitated health care premiums, or fee-for-service withhold amounts paid under contracts established under other state law.

(q) Engaging in abusive or fraudulent billing practices, including violations of the federal Medicare and Medicaid laws or state medical assistance laws.

(r) Becoming addicted or habituated to a drug or intoxicant.

(s) Prescribing a drug or device for other than medically accepted therapeutic or experimental or investigative purposes authorized by a state or federal agency or referring a patient to any health care provider as defined in section 144.335 for services or tests not medically indicated at the time of referral.

(t) Engaging in conduct with a patient which is sexual or may reasonably be interpreted by the patient as sexual, or in any verbal behavior which is seductive or sexually demeaning to a patient.

(u) Failure to make reports as required by section 147.111 or to cooperate with an investigation of the board as required by section 147.131.

(v) Knowingly providing false or misleading information that is directly related to the care of that patient unless done for an accepted therapeutic purpose such as the administration of a placebo.

(w) Aiding suicide or aiding attempted suicide in violation of section 609.215 as established by any of the following:

(1) a copy of the record of criminal conviction or plea of guilty for a felony in violation of section 609.215, subdivision 1 or 2;

(2) a copy of the record of a judgment of contempt of court for violating an injunction issued under section 609.215, subdivision 4;

(3) a copy of the record of a judgment assessing damages under section 609.215, subdivision 5; or

(4) a finding by the board that the person violated section 609.215, subdivision 1 or 2. The board shall investigate any complaint of a violation of section 609.215, subdivision 1 or 2.

(x) Practice of a board-regulated profession under lapsed or nonrenewed credentials.

(y) Failure to repay a state or federally secured student loan in accordance with the provisions of the loan.

(z) Failure to use the current and prevailing standard of care when making a utilization review determination as defined in section 62M.02."

Renumber the sections in sequence

They do not apply to the House committee on Capital Investment, Ways and Means, Taxes, Redistricting, or Rules and Legislative Administration, or to the Senate committee on Capital Investment, Finance, Taxes, or Rules and Administration.

(1) The first deadline, Friday, March 30, is for committees to act favorably on bills in the house of origin.

(2) The second deadline, Wednesday, April 11, is for committees to act favorably on bills, or companions of bills, that met the first deadline in the other house.

A committee has until the second deadline to act favorably on a bill, or the companion of a bill, that by the first deadline was referred to a finance committee.

(3) The omnibus appropriation bills are exempt from the first two deadlines. The deadline for committees to act favorably on omnibus appropriation bills is Wednesday, April 25.

(b) The omnibus appropriation bills are the following:

- (1) A bill in the House appropriating money for family and early childhood education;
- (2) A bill in the House appropriating money for education in kindergarten through grade 12;
- (3) A bill in the Senate appropriating money for education from early childhood through grade 12;
- (4) A bill appropriating money for higher education;
- (5) A bill in the House appropriating money for health and human services;
- (6) A bill in the Senate appropriating money for health, human services, and corrections;
- (7) A bill in the House appropriating money for crime prevention and the judiciary;
- (8) A bill in the House appropriating money for jobs and economic development;
- (9) A bill in the House appropriating money for the general administrative expenses of state government;
- (10) A bill in the Senate appropriating money for state government, economic development, and the judiciary;
- (11) A bill in the House appropriating money for agriculture and rural development;
- (12) A bill in the House appropriating money for the protection and improvement of the State's environment and natural resources;
- (13) A bill in the Senate appropriating money for the protection and improvement of the State's environment, natural resources, and agriculture;
- (14) A bill appropriating money for the department of transportation and other agencies;
- (15) A bill appropriating money for the payment of claims against the State of Minnesota that may have been allowed by the Finance Committee of the Senate or the Ways and Means Committee of the House; and
- (16) A bill appropriating money for the acquisition and betterment of public lands and buildings and other public improvements of a capital nature.

(c) When a committee in either house acts favorably on a bill after a deadline established in this resolution, the bill must be referred in the Senate to the Committee on Rules and Administration or in the House of Representatives to the Committee on Rules and Legislative Administration for disposition. Either rules committee, when reporting a bill referred to the committee in accordance with Joint Rule 2.03 and this resolution, may waive the application of the Rule and resolution to subsequent actions on that bill by other committees.
