Dear Madam President:

I have received, approved, signed, and deposited in the Office of the Secretary of the State Chapter 293, Senate File 1770, the Timberjay bill, with the exception of the line item veto listed below:

The following items of appropriation are vetoed for the reasons below:

Page 1, lines 1.15-1.17: "Receipts credited to the account are appropriated to the legislative auditor for the purpose of oversight relating to security of data stored and transmitted by state systems."

I have great respect for the Legislative Auditor and the important work of his office to promote accountability among state agencies, improve how state government operates, and ensure we are good stewards of taxpayers dollars. It is with those same principles in mind that I regretfully line item veto this open and standing appropriation.

It is not fiscally responsible to appropriate an ongoing amount of money without articulating the cost to perform the new duties outlined in the law. By next session, the Department of Public Safety will be better able to estimate the revenue generated to the data security account, and the Legislative Auditor will have time to estimate the cost to provide oversight relating to the security of data stored by all state systems.

In addition, I am concerned that the Legislature did not include an appropriation to MN.IT Services. Data security is an important state-wide issue; yet this legislation focuses only on the Commissioner of Public Safety's prudent efforts to better ensure the security and proper usage of driver license and license plate data by third parties. One of MN.IT's primary duties is to identify and manage potential vulnerabilities in state systems before they are exploited by those who wish to gain access to sensitive state data.

Finally, existing law already provides the Legislative Auditor broad authority to oversee state agency data security. I welcome that oversight and appreciate the Legislature's strong commitment to data

security. I urge the Legislature to work with interested parties next session to ensure there is proper funding and oversight across state government for the protection of private data.

Dear Madam President:

After careful consideration, I have vetoed and am returning Chapter 303, Senate File 2642, "A bill for an act relating to regulated industries...; suspending the sale of certain tickets of the state lottery through a Web site or self-service devices..."

In 1988, a strong majority of Minnesota voters (57 percent) approved a Constitutional Amendment to establish a state-run lottery. Since then, the Minnesota State Lottery has generated \$2.3 billion

to support the state's General Fund and Environmental Trust Fund. Those revenues benefit Minnesotans by helping to fund education, transportation, parks, hunting and fishing programs, and programs to protect and preserve our environment.

The internet is an increasingly common way for the public to access services. By taking steps to modernize its operations and make the same games it sells in paper form available in new ways, the Lottery is attempting to respond to changes in technology and public preferences.

Legislators have raised concerns that they expect to be kept better informed of the Lottery's efforts. Those constructive professional relationships are essential to the success of any enterprise in the Executive Branch, and I urge the Lottery to re-establish them with legislators before the next legislative session.

With all due respect, however, the authorization for the Lottery stems directly from the people of Minnesota, who instructed the Legislature to establish the Minnesota Lottery. The statutory language providing for a Lottery broadly defines the powers and duties of the Executive Director. Minnesota Statutes 349.02 states, in part: "In operating the lottery the director shall exercise the following powers and duties: (1) adopt rules and game procedures; (2) issue lottery retailer contracts ..." It appears to me that the Executive Director is operating within the scope of his legislatively-established authority.

Finally, while it is unfortunate that the provisions limiting lottery sales were added to a bill initially intended to make reasonable changes to charitable gambling laws, I am committed to working with the Gambling Control Board and the charitable gaming industry to ensure that appropriate provisions become law next legislative session.

For those reasons, I am vetoing this bill.
