## REPORTS OF COMMITTEES

Senator Gazelka moved that the Committee Reports at the Desk be now adopted, with the exception of the report on S.F. No. 749. The motion prevailed.

**Senator Lang from the Committee on Veterans and Military Affairs Finance and Policy, to which was referred**

**S.F. No. 363:** A bill for an act relating to veterans; authorizing the commissioner of veterans affairs to establish a veterans stable housing initiative; classifying certain homeless veterans data; authorizing data sharing; proposing coding for new law in Minnesota Statutes, chapter 196.

Reports the same back with the recommendation that the bill do pass and be re-referred to the Committee on Civil Law and Data Practices Policy. Report adopted.

**Senator Ruud from the Committee on Environment and Natural Resources Policy and Legacy Finance, to which was referred**

**S.F. No. 511:** A bill for an act relating to tourism; appropriating money for Explore Minnesota Tourism.

Reports the same back with the recommendation that the bill do pass and be re-referred to the Committee on Environment and Natural Resources Finance. Report adopted.

**Senator Ruud from the Committee on Environment and Natural Resources Policy and Legacy Finance, to which was referred**

**S.F. No. 514:** A bill for an act relating to state lands; modifying provisions for conveying state land interests; adding to and deleting from state parks and recreation areas; authorizing sales of certain state lands; amending Minnesota Statutes 2020, sections 84.63; 92.502.

Reports the same back with the recommendation that the bill do pass and be re-referred to the Committee on Environment and Natural Resources Finance. Report adopted.

**Senator Ruud from the Committee on Environment and Natural Resources Policy and Legacy Finance, to which was referred**

**S.F. No. 672:** A bill for an act relating to natural resources; classifying data on individuals who are minors; amending Minnesota Statutes 2020, section 13.7931, by adding a subdivision; proposing coding for new law in Minnesota Statutes, chapter 84.

Reports the same back with the recommendation that the bill do pass and be re-referred to the Committee on Civil Law and Data Practices Policy. Report adopted.

**Senator Kiffmeyer from the Committee on State Government Finance and Policy and Elections, to which was referred**

**S.F. No. 4:** A bill for an act relating to public safety; requiring legislative approval to extend the duration of a peacetime emergency declared by the governor; limiting duration of peacetime emergency extensions; amending Minnesota Statutes 2020, section 12.31, subdivision 2.

**Senator Dahms from the Committee on Commerce and Consumer Protection Finance and Policy, to which was referred**

**Senator Newman from the Committee on Transportation Finance and Policy, to which was re-referred**

**S.F. No. 302:** A bill for an act relating to transportation; designating a portion of marked Trunk Highway 13 in Waseca County as "Corporal Caleb L. Erickson Memorial Highway"; amending Minnesota Statutes 2020, section 161.14, by adding a subdivision.

Reports the same back with the recommendation that the bill do pass. Report adopted.

**Senator Newman from the Committee on Transportation Finance and Policy, to which was referred**

**S.F. No. 640:** A bill for an act relating to motor vehicles; modifying the class of vehicles requiring a salvage certificate of title; appropriating money; amending Minnesota Statutes 2020, section 168A.151, subdivision 1.

Reports the same back with the recommendation that the bill be amended as follows:

Page 2, delete section 2 and insert:

"Sec. 2. APPROPRIATION.

\$441,000 in fiscal year 2022 and \$395,000 in fiscal year 2023 are appropriated from the vehicle services operating account in the special revenue fund to the commissioner of public safety for the costs of two additional vehicle inspection sites, including the costs of equipment and staff."

And when so amended the bill do pass and be re-referred to the Committee on Finance. Amendments adopted. Report adopted.

**Senator Newman from the Committee on Transportation Finance and Policy, to which was referred**

**S.F. No. 625:** A bill for an act relating to transportation; modifying allocation of state general sales tax revenue related to motor vehicle repair and replacement parts; amending Minnesota Statutes 2020, section 297A.94.

Reports the same back with the recommendation that the bill be amended as follows:

Page 1, after line 5, insert:

**"Section 1. [174.523] TOWNSHIP ROAD IMPROVEMENT GRANT PROGRAM; APPROPRIATIONS.**

Subdivision 1. Township road improvement accounts. (a) A township road improvement account is created in the special revenue fund in the state treasury. The account consists of money transferred to the fund by law and any other money donated, allotted, transferred, or otherwise provided to the account. Money in the account is appropriated to the commissioner for grants, as provided in this section.

(b) A township road improvement account is created in the bond proceeds fund. The account consists of state bond proceeds and is appropriated to the commissioner for grants under this section. Grants from this account may only be expended for purposes that are permitted under the Minnesota Constitution, article XI, section 5.

Subd. 2. Advisory committee. (a) The commissioner shall establish a township road improvement advisory committee consisting of five members, including:

- (1) three township officers; and
- (2) two engineers who do work for townships.

(b) The advisory committee shall provide recommendations to the commissioner regarding expenditures from the accounts established in this section.

Subd. 3. Grant procedures and criteria. The commissioner shall establish procedures for towns to apply for grants or loans from the accounts created under subdivision 1 and criteria to be used to select projects for funding. The commissioner shall establish these procedures and criteria in consultation with representatives of the Minnesota Association of Townships and the appropriate state agency as needed. The criteria for determining project priority and the amount of a grant or loan must be based on consideration of:

- (1) the availability of other state, federal, and local funds;
- (2) the effectiveness of the proposed project in eliminating a transportation system deficiency;
- (3) the number of people who will be positively impacted by the project;
- (4) the project's contribution to local, regional, or state economic development or redevelopment efforts, including livestock or other agricultural operations, logging, and mining; and
- (5) the ability of the town to adequately provide for the safe operation and maintenance of the road or facility upon project completion.

Subd. 4. Administrative costs. A sum of 0.25 percent of the total amount in the accounts created under subdivision 1, other than deposited amounts from the proceeds from the sale of state bonds, is available to be used for administrative costs incurred by the department in carrying out the provisions of this section."

Page 2, line 31, delete "60" and insert "54" and delete "and"

Page 2, after line 31, insert:

"(2) three percent to the small cities assistance account in the special revenue fund established under section 162.145;

(3) three percent to the township road improvement account in the special revenue fund established under section 174.523; and"

Page 2, line 32, delete "(2)" and insert "(4)"

Page 4, delete line 20, and insert:

"Sec. 3. **EFFECTIVE DATE.**

This act is effective July 1, 2021."

Renumber the sections in sequence

Amend the title as follows:

Page 1, line 2, after the semicolon, insert "creating the township road improvement grant program; appropriating money;"

Page 1, line 3, after the semicolon, insert "dedicating sales tax revenue to small cities assistance program and township road improvement grant program;"

Amend the title numbers accordingly

And when so amended the bill do pass and be re-referred to the Committee on Taxes. Amendments adopted. Report adopted.

**Senator Ingebrigtsen from the Committee on Environment and Natural Resources Finance, to which was referred**

**S.F. No. 167:** A bill for an act relating to environment; prioritizing expenditures from dry cleaner environmental response and reimbursement account; banning perchloroethylene; modifying prior appropriation; appropriating money for cost-share program; amending Minnesota Statutes 2020, section 115B.49, subdivision 3; Laws 2019, First Special Session chapter 4, article 1, section 2, subdivision 10; proposing coding for new law in Minnesota Statutes, chapter 325E.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. Minnesota Statutes 2020, section 115B.49, subdivision 3, is amended to read:

Subd. 3. **Expenditures.** (a) Money in the account may be used:

(1) for environmental response costs incurred by the commissioner under section 115B.50, subdivision 1;

(2) for reimbursement of amounts spent by the commissioner from the remediation fund for expenses described in clause (1);

(3) for reimbursements under section 115B.50, subdivision 2; and

(4) for administrative costs of the commissioner of revenue.

(b) Money in the account is appropriated to the commissioner for the purposes of this subdivision. The commissioner shall transfer funds to the commissioner of revenue sufficient to cover administrative costs pursuant to paragraph (a), clause (4).

(c) In making reimbursements from the account, the commissioner must give priority to the following cases, in descending order:

(1) reimbursements for amounts spent on response actions by a person who meets the conditions of section 115B.48, subdivision 10, clause (2); and

(2) reimbursements for expenditures made by the commissioner under paragraph (a), clause (1) or (2), on behalf of owners or operators when the owner or operator failed to complete the requested response action and the commissioner undertook the response action to remediate the property.

**EFFECTIVE DATE.** This section is effective the day following final enactment.

Sec. 2. **[325E.381] PERCHLOROETHYLENE PROHIBITION.**

After December 31, 2025, using perchloroethylene as a dry cleaning solvent is prohibited.

**EFFECTIVE DATE.** This section is effective the day following final enactment.

Sec. 3. **CANCELLATION.**

The transfer of any unexpended funds under Laws 2019, First Special Session chapter 4, article 1, section 2, subdivision 10, paragraph (c), estimated to be \$255,000, is canceled.

**EFFECTIVE DATE.** This section is effective the day following final enactment.

Sec. 4. **APPROPRIATIONS.**

(a) \$355,000 in fiscal year 2021 is appropriated from the remediation fund to the commissioner of the Pollution Control Agency for a cost-share program to reimburse owners or operators of dry cleaning facilities for the costs of transitioning from perchloroethylene to alternative solvents that are technically viable and environmentally preferred, as determined by the commissioner. The commissioner must reimburse an owner's or operator's transition expenses up to \$20,000. This is a onetime appropriation and is available until June 30, 2024.

(b) Notwithstanding Minnesota Statutes, section 115B.49, subdivision 3, paragraph (b), \$213,000 in fiscal year 2021 is appropriated from the dry cleaner environmental response and reimbursement



account in the remediation fund to the commissioner of the Pollution Control Agency for the purposes of Minnesota Statutes, section 115B.49. In reimbursing persons with funds appropriated under this paragraph, the commissioner must give priority to persons who meet the definition in Minnesota Statutes, section 115B.48, subdivision 10, clause (2), and who have made a request to the commissioner under Minnesota Statutes, section 115B.50, subdivision 2. This is a onetime appropriation and is available until June 30, 2022.

**EFFECTIVE DATE.** This section is effective the day following final enactment."

Delete the title and insert:

"A bill for an act relating to environment; prioritizing expenditures from dry cleaner environmental response and reimbursement account; banning perchloroethylene; canceling a prior appropriation; appropriating money for a cost-share program and for environmental response costs; amending Minnesota Statutes 2020, section 115B.49, subdivision 3; proposing coding for new law in Minnesota Statutes, chapter 325E."

And when so amended the bill do pass and be re-referred to the Committee on Finance. Amendments adopted. Report adopted.

**Senator Newman from the Committee on Transportation Finance and Policy, to which was referred**

**S.F. No. 140:** A bill for an act relating to public safety; establishing a misdemeanor for traffic violations that cause great bodily harm or death to another; amending Minnesota Statutes 2020, section 169.13, subdivision 2.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. Minnesota Statutes 2020, section 169.13, subdivision 2, is amended to read:

Subd. 2. **Careless driving.** (a) Any person who operates or halts any vehicle upon any street or highway carelessly or heedlessly in disregard of the rights of others, or in a manner that endangers or is likely to endanger any property or any person, including the driver or passengers of the vehicle, is guilty of a misdemeanor.

(b) Any person who operates or halts a light rail transit vehicle carelessly or heedlessly in disregard of the rights of others, or in a manner that endangers or is likely to endanger any property or any person, including the operator or passengers on the light rail transit vehicle, is guilty of a misdemeanor.

(c) Notwithstanding section 609.101, subdivision 4, the Judicial Council may not place a violation of this subdivision that causes great bodily harm or death to another on the uniform fine schedule.

**EFFECTIVE DATE.** This section is effective August 1, 2021, and applies to crimes committed on or after that date."

Amend the title as follows:

Page 1, line 2, delete everything after the semicolon and insert "prohibiting certain careless driving violations from appearing on the uniform fine schedule"

Page 1, line 3, delete everything before the semicolon

And when so amended the bill do pass and be re-referred to the Committee on Judiciary and Public Safety Finance and Policy. Amendments adopted. Report adopted.

**Senator Rarick from the Committee on Labor and Industry Policy, to which was referred**

**S.F. No. 524:** A bill for an act relating to the State Building Code; clarifying building and fire code requirements for public places of accommodation that are rural event centers; authorizing rulemaking; amending Minnesota Statutes 2020, section 326B.108, by adding a subdivision.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. Minnesota Statutes 2020, section 326B.108, subdivision 1, is amended to read:

Subdivision 1. **Definition.** For purposes of this section, "place of public accommodation" means a publicly or privately owned facility that is designed for occupancy by ~~200~~ 100 or more people and is a sports or entertainment arena, stadium, theater, community or convention hall, special event center, indoor amusement facility or water park, or indoor swimming pool.

**EFFECTIVE DATE.** This section is effective the day following final enactment.

Sec. 2. Minnesota Statutes 2020, section 326B.108, subdivision 3, is amended to read:

Subd. 3. **Enforcement.** Effective July 1, 2017, in a municipality that has not adopted the code by ordinance under section 326B.121, subdivision 2, the commissioner shall enforce this section in accordance with section 326B.107, subdivision 1.

**EFFECTIVE DATE.** This section is effective the day following final enactment.

Sec. 3. Minnesota Statutes 2020, section 326B.108, is amended by adding a subdivision to read:

**Subd. 5. Fire sprinklers required.** Automatic sprinkler systems for fire protection purposes are required in a place of public accommodation if, on or after August 1, 2008:

(1) the facility was constructed, added to, or altered; and

(2) the facility has an occupant load of 300 or more.

**EFFECTIVE DATE.** This section is effective the day following final enactment."

Amend the title as follows:

Page 1, line 2, delete everything after the semicolon and insert "modifying state building code applicability and fire sprinkler requirements for public places of accommodation"

Page 1, delete line 3

Page 1, line 4, delete everything before the semicolon

Amend the title numbers accordingly

And when so amended the bill do pass and be re-referred to the Committee on Judiciary and Public Safety Finance and Policy. Amendments adopted. Report adopted.

**Senator Nelson from the Committee on Taxes, to which was referred**

**S.F. No. 749:** A bill for an act relating to local government aid; authorizing the commissioner of revenue to adjust local government aid amounts for cities with unpaid local assistance amounts; proposing coding for new law in Minnesota Statutes, chapter 477A.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. [477A.0177] ADJUSTMENT FOR UNPAID LOCAL ASSISTANCE AMOUNTS.

Subdivision 1. Definitions. (a) For purposes of this section, the following terms have the meanings given.

(b) "City" has the meaning given in section 477A.011.

(c) "Local government" means a county or a city.

(d) "Unpaid amount" means an amount that is owed to a local government by another local government under section 12.331, subdivision 2, or an amount that is owed to a local government by another local government under the terms of a written mutual aid agreement under section 12.27. Unpaid amount does not include:

(1) an amount attributable to local assistance activities occurring before January 1, 2021;

(2) an amount under a written mutual aid agreement that specifies a schedule for payment of amounts due; or

(3) an amount reimbursed by the state under section 12.33, subdivision 4.

Subd. 2. **Application to state auditor; certification of unpaid amounts.** (a) Beginning with financial statements due to the state auditor in 2022 and annually thereafter, a local government that is owed an unpaid amount attributable to activities occurring in the previous calendar year may submit with its financial statements an application for an adjustment to the aid calculated under sections 477A.011 to 477A.03.

(b) The application must be in the form and manner determined by the state auditor. The application must indicate the unpaid amount owed to the local government as of the date of the application, identify the local government that owes the amount, and include any other information required by the state auditor. If the unpaid amount is owed under the terms of a written mutual aid agreement, the application must include a copy of the written agreement. The state auditor may request information from a local government reported to owe an unpaid amount.

(c) Within 30 days of the application submission, the state auditor must determine the unpaid amount owed, if any, and certify that amount to the commissioner of revenue.

Subd. 3. **Certified aid adjustments.** (a) Notwithstanding any other law to the contrary, beginning with aids payable in 2022, the commissioner of revenue must adjust aid under sections 477A.011 to 477A.03 as provided in this subdivision. The adjustments must be made to the first aid payment made after certification of the unpaid amount from the state auditor.

(b) The commissioner must reduce the aid paid to a local government by the sum of the certified unpaid amounts owed by that local government for the previous calendar year. A local government's aid payment after adjustment under this paragraph may not be less than zero. If the local government's aid payment under sections 477A.011 to 477A.03 before adjustment is less than the full amount of the adjustment under this paragraph, the remaining balance of the adjustment must be applied to future aid payments until the total amount of the adjustment has been subtracted from aid payments to the local government.

(c) The commissioner must increase the aid paid to a local government by the sum of the aid reductions under paragraph (b) attributable to the certified unpaid amount owed to the local government.

Subd. 4. **Effect of adjustment on future aid.** The commissioner must not consider the adjustments under this section for the purpose of calculating aid payable in the year following the adjustments."

And when so amended the bill do pass.

**INTRODUCTION AND FIRST READING OF SENATE BILLS**

The following bills were read the first time.
