**S.F. No. 640:** A bill for an act relating to motor vehicles; modifying the class of vehicles requiring a salvage certificate of title; appropriating money; amending Minnesota Statutes 2020, section 168A.151, subdivision 1.

Reports the same back with the recommendation that the bill do pass. Report adopted.

**Senator Benson from the Committee on Health and Human Services Finance and Policy, to which was referred**

**S.F. No. 953:** A bill for an act relating to health; providing an exception to the hospital moratorium; amending Minnesota Statutes 2020, section 144.551, subdivision 1.

Reports the same back with the recommendation that the bill do pass. Report adopted.

**Senator Benson from the Committee on Health and Human Services Finance and Policy, to which was referred**

**S.F. No. 1182:** A bill for an act relating to child welfare; modifying requirements for reporting prenatal substance use; amending Minnesota Statutes 2020, section 260E.31, subdivision 1.

Reports the same back with the recommendation that the bill be amended as follows:

Page 1, line 17, after the period, insert "If the woman does not continue to receive regular prenatal or postpartum care, after the woman's health care professional has made attempts to contact the woman, then the professional is required to report under paragraph (a)."

And when so amended the bill do pass and be re-referred to the Committee on Civil Law and Data Practices Policy. Amendments adopted. Report adopted.

**Senator Benson from the Committee on Health and Human Services Finance and Policy, to which was referred**

**S.F. No. 1156:** A bill for an act relating to health care; increasing medical assistance reimbursement rate for administration of COVID-19 vaccine.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. INCREASE IN MEDICAL ASSISTANCE REIMBURSEMENT RATE FOR COVID-19 VACCINATION ADMINISTRATION.

(a) Notwithstanding Minnesota Statutes, section 256B.76, the medical assistance reimbursement rate for administering the COVID-19 vaccination is the Medicare rate for health care professionals who administer a COVID-19 vaccine to a medical assistance enrollee in accordance with the professional's scope of practice.

(b) This section expires on the last day of the calendar quarter in which the federal public health emergency for COVID-19 ends.

EFFECTIVE DATE. This section is effective the day following final enactment.

Sec. 2. APPROPRIATION.

The commissioner of management and budget shall review all appropriations and transfers from the general fund in Laws 2020, chapters 66, 70, 71, 74, and 81, to determine whether those

appropriations and transfers are eligible expenditures from the coronavirus relief federal fund. The commissioner shall designate \$98,000 of general fund appropriations and transfers in Laws 2020, chapters 66, 70, 71, 74, and 81, to be an eligible expenditure from the coronavirus relief federal fund. The commissioner may designate a portion of an appropriation or transfer for cancellation. \$98,000 of the appropriations and transfers designated by the commissioner are canceled to the general fund. \$98,000 is appropriated from the coronavirus relief federal fund for the purposes of the original general fund appropriation. \$12,000 in fiscal year 2021 and \$86,000 in fiscal year 2022 are appropriated from the general fund to the commissioner of human services for payments for COVID-19 vaccine administration under section 1.

**EFFECTIVE DATE.** This section is effective the day following final enactment."

And when so amended the bill do pass and be re-referred to the Committee on Finance. Amendments adopted. Report adopted.

**Senator Ruud from the Committee on Environment and Natural Resources Policy and Legacy Finance, to which was re-referred**

**S.F. No. 566:** A bill for an act relating to environment; repealing recent restrictions on spreading manure and prohibiting future restrictions; amending Minnesota Statutes 2020, section 116.07, subdivision 7.

Reports the same back with the recommendation that the bill be amended as follows:

Page 2, line 34, after "permit" insert "issued by the Pollution Control Agency"

And when so amended the bill do pass. Amendments adopted. Report adopted.

**Senator Ruud from the Committee on Environment and Natural Resources Policy and Legacy Finance, to which was referred**

**S.F. No. 1110:** A bill for an act relating to waters; modifying provisions for managing water and issuing permits to appropriate water; amending Minnesota Statutes 2020, sections 103G.255; 103G.271, subdivision 4a, by adding a subdivision.

Reports the same back with the recommendation that the bill do pass. Report adopted.

**Senator Limmer from the Committee on Judiciary and Public Safety Finance and Policy, to which was referred**

**S.F. No. 870:** A bill for an act relating to public safety; clarifying the maximum length of stayed sentences for certain offenses; amending Minnesota Statutes 2020, section 609.135, subdivision 2.

Reports the same back with the recommendation that the bill be amended as follows:

Page 3, lines 22 and 23, after "attempt" insert "or conspiracy"

And when so amended the bill do pass. Amendments adopted. Report adopted.

**Senator Limmer from the Committee on Judiciary and Public Safety Finance and Policy, to which was referred**

**S.F. No. 592:** A bill for an act relating to labor; providing a salary increase for employees in law enforcement and making a technical change; appropriating money; amending Laws 2020, Fifth Special Session chapter 3, article 9, section 6.

Reports the same back with the recommendation that the bill do pass and be re-referred to the Committee on Environment and Natural Resources Finance. Report adopted.

**Senator Koran from the Committee on Technology and Reform Policy, to which was referred**

**S.F. No. 1174:** A bill for an act relating to state government; establishing a Legislative Commission on Cybersecurity; providing legislative appointments; proposing coding for new law in Minnesota Statutes, chapter 3.

Reports the same back with the recommendation that the bill do pass and be re-referred to the Committee on State Government Finance and Policy and Elections. Report adopted.

**Senator Lang from the Committee on Veterans and Military Affairs Finance and Policy, to which was referred**

**S.F. No. 249:** A bill for an act relating to veterans; appropriating funds for veteran retreats.

Reports the same back with the recommendation that the bill do pass and be re-referred to the Committee on Finance. Report adopted.

Page 1, line 11, before "the" insert "the Laos Secret War,"

And when so amended the resolution do pass and be re-referred to the Committee on Rules and Administration. Amendments adopted. Report adopted.

**Senator Lang from the Committee on Veterans and Military Affairs Finance and Policy, to which was referred**

**S.F. No. 669:** A resolution memorializing the United States government to honor veterans by funding construction costs for proposed veterans homes in Bemidji, Montevideo, and Preston.

Reports the same back with the recommendation that the resolution do pass and be re-referred to the Committee on Rules and Administration. Report adopted.

**Senator Newman from the Committee on Transportation Finance and Policy, to which was referred**

**S.F. No. 1158:** A bill for an act relating to transportation; making appropriations for aeronautics purposes.

**S.F. No. 1215:** A bill for an act relating to transportation; prohibiting the establishment of a bikeway if it would eliminate or relocate disability parking; amending Minnesota Statutes 2020, section 160.263, subdivision 2.

Reports the same back with the recommendation that the bill do pass. Report adopted.

**Senator Newman from the Committee on Transportation Finance and Policy, to which was referred**

**S.F. No. 1161:** A bill for an act relating to transportation; modifying classification and regulation of electric-assisted bicycles; amending Minnesota Statutes 2020, sections 84.787, subdivision 7; 84.797, subdivision 7; 84.92, subdivision 8; 168.002, subdivision 18; 169.011, subdivisions 27, 42, by adding subdivisions; 169.222, subdivisions 4, 6a, by adding a subdivision.

Reports the same back with the recommendation that the bill do pass and be re-referred to the Committee on Environment and Natural Resources Policy and Legacy Finance. Report adopted.

**Senator Newman from the Committee on Transportation Finance and Policy, to which was referred**

**S.F. No. 519:** A bill for an act relating to corrections; providing identification cards for offenders released from incarceration; amending Minnesota Statutes 2020, section 171.06, subdivision 3.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. Minnesota Statutes 2020, section 171.06, subdivision 3, is amended to read:

Subd. 3. **Contents of application; other information.** (a) An application must:

(1) state the full name, date of birth, sex, and either (i) the residence address of the applicant, or (ii) designated address under section 5B.05;

(2) as may be required by the commissioner, contain a description of the applicant and any other facts pertaining to the applicant, the applicant's driving privileges, and the applicant's ability to operate a motor vehicle with safety;

(3) state:

(i) the applicant's Social Security number; or

(ii) if the applicant does not have a Social Security number and is applying for a Minnesota identification card, instruction permit, or class D provisional or driver's license, that the applicant certifies that the applicant is not eligible for a Social Security number;

(4) contain a notification to the applicant of the availability of a living will/health care directive designation on the license under section 171.07, subdivision 7; and

(5) include a method for the applicant to:

(i) request a veteran designation on the license under section 171.07, subdivision 15, and the driving record under section 171.12, subdivision 5a;

(ii) indicate a desire to make an anatomical gift under paragraph (d);

(iii) as applicable, designate document retention as provided under section 171.12, subdivision 3c; and

(iv) indicate emergency contacts as provided under section 171.12, subdivision 5b.

(b) Applications must be accompanied by satisfactory evidence demonstrating:

(1) identity, date of birth, and any legal name change if applicable; and

(2) for driver's licenses and Minnesota identification cards that meet all requirements of the REAL ID Act:

(i) principal residence address in Minnesota, including application for a change of address, unless the applicant provides a designated address under section 5B.05;

(ii) Social Security number, or related documentation as applicable; and

(iii) lawful status, as defined in Code of Federal Regulations, title 6, section 37.3.

(c) An application for an enhanced driver's license or enhanced identification card must be accompanied by:

(1) satisfactory evidence demonstrating the applicant's full legal name and United States citizenship; and

(2) a photographic identity document.

(d) A valid Department of Corrections or Federal Bureau of Prisons identification card, containing the applicant's full name, date of birth, and photograph issued to the applicant is an acceptable form of proof of identity in an application for an identification card, instruction permit, or driver's license as a secondary document for purposes of Minnesota Rules, part 7410.0400, and successor rules.

Sec. 2. **[241.067] RELEASE OF INMATES; DUTIES OF COMMISSIONER.**

Subdivision 1. **Duties upon release.** When releasing an inmate from prison, the commissioner shall:

(1) provide the inmate with a copy of the inmate's unofficial criminal history compiled by the department and marked as unofficial;

(2) provide information to the inmate on how to obtain the inmate's full official criminal history from the Bureau of Criminal Apprehension;

(3) provide general information to the inmate describing the laws and processes for obtaining an expungement of the inmate's criminal record;

(4) provide general information on the inmate's right to vote;

(5) provide the inmate with current information on local career workforce centers in the county in which the inmate will reside and, upon the inmate's request, other counties;

(6) provide the inmate with a record of the programs that the inmate completed while in prison;

(7) provide the inmate with an accounting of any court-ordered payments, fines, and fees owed by the inmate upon release of which the department has knowledge;

(8) provide assistance to the inmate in obtaining a Social Security card;

(9) provide the inmate with a medical discharge summary;

(10) provide the inmate with information on how the inmate may obtain a complete copy of the inmate's medical record at no charge to the inmate; and

(11) provide the inmate with general information on the Supplemental Nutrition Assistance Program (SNAP) benefits, eligibility criteria, and application process.

Subd. 2. **Assistance relating to birth certificate and identification cards.** (a) Upon the request of an inmate, the commissioner shall assist the inmate in obtaining a copy of the inmate's birth certificate at no cost to the inmate. This assistance applies only to inmates who (1) upon intake have six months or more remaining in their term of imprisonment, (2) do not already have an accessible copy of their birth certificate available or other valid identification, or (3) do not already have a valid photograph on file with the Department of Public Safety that may be used as proof of identity for renewing an identification document.

(b) The commissioner, in collaboration with the Department of Public Safety, shall facilitate the provision of a state identification card to an inmate at no cost to the inmate under the same criteria described in paragraph (a) relating to birth certificates, provided the inmate possesses the necessary qualifying documents to obtain the card.

(c) The commissioner shall inform inmates of the commissioner's duties under paragraphs (a) and (b) upon intake and again upon the initiation of release planning.

Subd. 3. **Medical assistance or MinnesotaCare application.** At least 45 days before the scheduled release of an inmate, the commissioner shall offer to assist the inmate in completing an



application for medical assistance or MinnesotaCare and shall provide the assistance if the inmate accepts the offer.

Subd. 4. **Medications.** (a) When releasing an inmate from prison, the commissioner shall provide the inmate with a one-month supply of any non-narcotic medications that have been prescribed to the inmate and a prescription for a 30-day supply of these medications that may be refilled twice.

(b) Paragraph (a) applies only to the extent the requirement is consistent with clinical guidelines and permitted under state and federal law.

(c) Nothing in this subdivision overrides the requirements in section 244.054.

Subd. 5. **Exception; release violators.** With the exception of subdivision 4, this section does not apply to inmates who are being imprisoned for a release violation. The requirements in subdivision 4 apply to all inmates being released.

**EFFECTIVE DATE.** This section is effective September 1, 2021, except that the requirement in subdivision 1, clause (10), is effective on July 1, 2022.

Sec. 3. **[241.068] HOMELESSNESS MITIGATION PLAN; ANNUAL REPORTING ON HOMELESSNESS.**

Subdivision 1. **Homelessness mitigation plan; report.** (a) The commissioner of corrections shall develop and implement a homelessness mitigation plan for individuals released from prison. At minimum, the plan must include:

(1) redesigning of business practices and policies to boost efforts to prevent homelessness for all persons released from prison;

(2) efforts to increase interagency and intergovernmental collaboration between state and local governmental units to identify and leverage shared resources; and

(3) development of internal metrics for the agency to report on its progress towards implementing the plan and achieving the plan's goals.

(b) The commissioner shall submit the plan to the chairs and ranking minority members of the legislative committees having jurisdiction over criminal justice policy and funding by October 31, 2022.

Subd. 2. **Reporting on individuals released to homelessness.** (a) By February 15 of each year beginning in 2022, the commissioner shall report to the chairs and ranking minority members of the legislative committees having jurisdiction over criminal justice policy and funding the following information on adults, disaggregated by race, gender, and county of release:

(1) the total number released to homelessness from prison;

(2) the total number released to homelessness by each Minnesota correctional facility;

(3) the total number released to homelessness by county of release; and

(4) the total number under supervised, intensive supervised, or conditional release following release from prison who reported experiencing homelessness or a lack of housing stability.

(b) Beginning with the 2024 report and continuing until the 2033 report, the commissioner shall include in the report required under paragraph (a), information detailing progress, measures, and challenges to the implementation of the homelessness mitigation plan required by subdivision 1.

**EFFECTIVE DATE.** This section is effective July, 1, 2021."

Delete the title and insert:

"A bill for an act relating to corrections; requiring that certain information, assistance, services, and medications be provided to inmates upon release from prison; providing identification cards for released inmates; requiring a homelessness mitigation plan and annual reporting on information relating to homelessness; amending Minnesota Statutes 2020, section 171.06, subdivision 3; proposing coding for new law in Minnesota Statutes, chapter 241."

### SPECIAL ORDER

**S.F. No. 694:** A bill for an act relating to state government; extending the operation of the Minnesota premium security plan; amending Laws 2017, chapter 13, article 1, section 15, as amended.

Senator Port moved to amend S.F. No. 694 as follows:

Page 1, after line 4, insert:

"Section 1. **[62E.26] LIMITS ON CEO COMPENSATION FOR ENTITIES RECEIVING REINSURANCE PAYMENTS.**

Subdivision 1. **General.** (a) The board of directors of an entity that receives reinsurance payments under section 62E.23 must ensure that:

(1) the chief executive officer must not receive total annual compensation from any source for work performed or services provided at or for the entity that is greater than the annual salary and expense allowance of the President of the United States as set forth in United States Code, title 3, section 102; and

(2) the total value of the compensation or payments authorized or paid under a severance or similar postservice or postemployment arrangement for the chief executive officer does not exceed the annual salary and expense allowance of the President of the United States as set forth in United States Code, title 3, section 102.

(b) "Total annual compensation" includes all remuneration paid, earned, or accrued in the course of a fiscal year for work performed or services provided, including the cash value of all remuneration, including benefits, in any medium other than cash. Total annual compensation includes, but is not limited to, wages; salary; paid time off; bonuses; incentive payments; lump-sum cash payments; the fair market value of below market rate loans or loan forgiveness; housing payments; payments for transportation, travel, meals, or other expenses in excess of actual documented expenses incurred in the performance of duties; the cash value of housing, automobiles, parking, or similar benefits; scholarships or fellowships; the cash value of stock options or awards; payments or contributions for insurance or to a section 125 cafeteria plan or equivalent arrangement, to a health savings account, or for severance or its equivalent; and deferred compensation earned or accrued, even if not yet vested nor paid.

(c) The total value of a severance or similar postemployment or postservice compensation arrangement or severance payments includes the fair market value of all cash remuneration as well as the fair market value of all remuneration, including benefits, paid in any medium other than cash, as defined in paragraph (b).

(d) Any compensation paid for work performed or services provided by the chief executive officer must be included in determining the total compensation subject to the limit set forth in paragraph (a), even if that person also performs or performed other duties.



Subd. 2. **Reporting.** (a) Within three months of the close of each fiscal year, the board of directors of an entity that receives reinsurance payments under section 62E.23 must submit a report to the attorney general that contains the name of the chief executive officer and the sources of any compensation, including any compensation paid pursuant to a severance agreement. The information provided must include a detailed breakdown of all wage and nonwage compensation.

(b) The board of directors submitting the report pursuant to paragraph (a) must approve the report before it is submitted to the attorney general. Each director has a duty to act in good faith and with reasonable care and inquiry in approving the annual report and in ensuring that the corporation complies with the requirements of this section.

(c) The report submitted pursuant to paragraph (a) must state that it was approved by the board of directors and set forth the date of the approval, and must be attested to under penalty of perjury by an authorized representative of the entity submitting the report.

(d) The report submitted pursuant to paragraph (a) must be submitted on the form or in the format required by the attorney general.

(e) The report submitted pursuant to paragraph (a) must be posted on a publicly available website and made available to any member of the public upon request.

(f) The attorney general is authorized and directed to establish and assess fees, to be submitted with each report pursuant to paragraph (a), to cover the costs of implementing and enforcing this subdivision.

Subd. 3. **Penalties.** (a) In addition to any other enforcement actions available under law, and notwithstanding any other provision of law, the attorney general or any state taxpayer may bring or intervene in a civil action for a violation of this section for the civil penalties authorized by section 8.31, subdivisions 3 and 3a, any other authorized civil fines or penalties, and appropriate equitable relief.

(b) Appropriate equitable relief may include a civil penalty not exceeding \$500,000.

(c) The attorney general may, to promote the purposes of this section, investigate the affairs of and examine the books, accounts, records, and files of an entity subject to this section.

(d) All penalties paid to the attorney general pursuant to this section must be deposited in the general fund in accordance with section 8.31, subdivision 3."

Amend the title accordingly
