## CALL OF THE SENATE

## REPORTS OF COMMITTEES

Senator Murphy moved that the Committee Reports at the Desk be now adopted. The motion prevailed.

**Senator Latz from the Committee on Judiciary and Public Safety, to which was referred**

**S.F. No. 3669:** A bill for an act relating to public safety; clarifying eligibility standard applicable to retroactive relief for certain persons convicted of aiding and abetting felony murder; making

conforming changes; amending Minnesota Statutes 2023 Supplement, sections 638.12, subdivision 2; 638.15, subdivision 1; Laws 2023, chapter 52, article 4, section 24, subdivisions 3, 4, 7.

Reports the same back with the recommendation that the bill be amended as follows:

Page 7, delete lines 12 to 17 and insert:

"(b) By July 1, 2024, the commissioner of corrections shall notify individuals to whom notice was previously provided under Laws 2023, chapter 52, article 4, section 24, subdivision 3, paragraph (a), clause (2), about the changes to law made in this act. The notice must inform the individual that the individual may apply or reapply for relief under Laws 2023, chapter 52, article 4, section 24, if eligible based on the changes made in this act."

And when so amended the bill do pass. Amendments adopted. Report adopted.
